The complainant, Shri Dilip Pashi, submitted that he is a person with benchmark locomotor disability and the son of Late Shri Ram Piare Pashi, a former Railway employee, and Smt. Lakshmi Pashi, the present family pensioner. He stated that his disability status had been verified in the Railway records. He submitted that he had sought endorsement of his name as a disabled dependent in his mother's PPO.

2. The respondent submitted that the current family pensioner (Complainant's mother) had not submitted any consent letter or other prescribed request regarding inclusion of the complainant's name in the PPO. The respondent further stated that there is a prescribed provision under which the pensioner is required to submit a request for inclusion or deletion of a family member's name, and that no such letter had been received from the current family pensioner. The respondent also submitted that the complainant's name was not included in the PPO as a dependent family member. During the hearing, it was further noted that

the complainant had submitted a disability certificate but had not produced a separate medical certificate certifying that, owing to his disability, he was incapable of undertaking employment.

3. The Court observed that, for determining the complainant's entitlement to family pension, it is required that his name had been included in the PPO/family details by the deceased employee and whether he possessed the requisite medical certificate certifying his incapacity to undertake employment on account of his disability. The Court clarified that a disability certificate is distinct from the medical certificate required for establishing incapacity to undertake employment for the purpose of consideration of family pension. Since the complainant had not established the aforesaid requirements before the Court, his claim for family pension could not be validated at this stage. The complainant was advised to obtain the requisite medical certificate from the Railway Hospital and approach the respondent authority along with the relevant documents, including the requisite request/consent of the family pensioner, for consideration of his claim.

4. If the respondent does not consider his claim after submission of the requisite documents, the complainant would be at liberty to approach the Court by filing a fresh complaint. Accordingly, the present case is hereby disposed of.
