8. सूचनादाता द्वारा देरी से सूचना दिये जाने का कारण :— कोई देरी नहीं। प्रथम सूचना रिपोर्ट का विवरण :—To SHO/PS/SVB/PKL, A letter received from the Chief Secretary to Govt. Haryana, Political & Parliamentary Affairs Department's vide No. 23/8/2009-3 Pol. dated 3.12.2014, in the office of Superintendent of Police, State Vigilance Bureau, Panchkula through Director General, State Vigilance Bureau, Haryana vide Endst. No. 16524/I-4/SVB

(H) dated 4.12.2014, SSP/SVB/PKL entrusted the same to Sh. Raj Pal, DSP/ SVB/ PKL. The contents of letter are as under:- I am directed to invite reference to the subject mentioned above and desired to say that a Memorandum along with a VCD was submitted by the Indian National Lok Dal to the H.E. Governor of Haryana in which allegations of corruption were levelled against Sh. Ram Kishan Fauji, Ex. Chief Parliamentary Secretary, Haryana. The Government after considering the matter had made a reference under section 8(1) of the Haryana Lokayukta Act, 2002 to the Hon'ble Lokayukta into the allegations contained in the VCD. The Hon'ble Lokayukta has submitted its findings to the State Government vide its Memo No. Lok/HR/2014/773/243 dated 20the January, 2014 (copy enclosed) in which the Hon'ble Lokayukta has recommended registrations of a criminal case against Sh. Ram Kishan Fauji, Ex Chief Parliamentary Secretary for the commission of offence punishable under the Prevention of Corruption Act, 1988. It is further submitted that Sh. Ram Kishan Fauji, Ex Chief Parliamentary Secretary filed C.W.P No. 4554 of 2014 in the Hon'ble High Court of Punjab and Haryana. The Hon'ble High Court vide its order dated 14.3.2014 directed the State Government to get the authenticity of the VCD examined. The Hon'ble High Court also directed that the respondent State shall be bound by the judgement of Lalita Kumari Vs. Government of U.P. and others 2013(4) criminal Court case 619. As per the directions of the Hon'ble High Court the Government has got the authenticity of the VCD examined from the Central Forensic Science Laboratory, Chandigarh. A copy of the report of Central Forensic Science Laboratory, Chandigarh is enclosed herewith for the ready reference. The State Government has considered the report of the Central Forensic Science Laboratory, Chandigarh and the findings of the Hon'ble Lokayukta and it has been decided that a criminal case for the commission of an offence punishable under the Prevention of Corruption Act, 1988 may be registered against Sh. Ram Kishan Fauji, Ex.

Chief Parliamentary Secretary, Haryana and investigation of the same may be entrusted to a senior competent police officer of impeccable integrity to investigate the entire case expeditiously on all counts of allegations of a corruption allegedly levelled in the VCD during the investigation. Sd/- Under Secretary Political. As per the report of Lokayukata attached with above letter, it has specifically been averred that on 28.04.2011 at about 2.30 P.M., Sh. Dharmender Kuhar and Sh. Parveen Malik had gone to the official residence of Shri Ram Kishan Fauji, the then chief parliamentary secretary, Govt. of Haryana at House No. 748, Sector-12-A, Panchkula and showed him certain papers relating to a land situated in District Gurgaon. During the course of their talks with Shri Ram Kishan Fauji, the papers were shown to him with a request to get the file of C.L.U. (Change of Land Use) cleared from the Government .The VCDs produced by Dharmender Kuhar and Parveen Malik, which were placed on the file of Lokayukta, were prepared by using a camera. Sh. Dharmender Kuhar had recorded the sting operation. Transcription of the relevant portion of VCD has also been mentioned in the report. Sh Ram Kishan Fauji, then Chief Parliamentary Secretary demanded Rs. 5 Crores for assisting in getting the change of land use from Sh. Dharmender Kuhar and Sh. Parveen Malik. Sh Ram Kishan Fauji, being a public servant made a demand of illegal gratification from Sh. Dharmender Kuhar and Sh. Parveen Malik and has committed offences under Section 7 and 8 of the Prevention of Corruption Act 1988. Sd.
