श्रीमान जी, तहरीर का मजबूत इस प्रकार से है "सेवा में प्रबन्धक, थाना, राज्य चौकसी ब्यूरो (ह0), पंचकूला मण्डल पंचकूला, सै0-17, पंचकूला। श्रीमान जी निवेदन है कि गांव चौकी, तहसील व जिला पंचकूला की एक्वायर भूमि की लगभग 60 करोड़ रुपये एक्सेस/अधिक पैमेन्ट करने बारे] श्री एम0एस0 सांगवान, भूमि अधिग्रहण अधिकारी, धूप सिंह नायब तहसीलदार, जैनाराम पटवारी व कमल नैन सैक्शन ऑफिसर व भू-मालिकों के विरुद्ध जेरधारा 218, 406, 409, 420, 120बी0, भा0द0सं0 व 13(1)सी0 भ्रष्टाचार उन्मूलन अधिनियम 1988, के तहत अभियोग दर्ज करने के लिए तहरीर तैयार करके निरीक्षक सुरेश कुमार, थाना राज्य चौकसी ब्यूरो, पंचकूला द्वारा पत्र क्रमांक 938/थाना, रा0चौ0ब्यूरां, पंचकूला, दिनांक 22-12-2016 को जिला न्यायवादी से वैट करवाने हेतु मुख्यालय, राज्य चौकसी ब्यूरो, हरियाणा, पंचकूला भेजी गई थी, जो तहरीर हजा जिला न्यायवादी से वैट होने उपरान्त वैटिड प्रति सरकार को भेजी गई थी, जो सरकार से अनुमति प्राप्त होने उपरान्त महानिदेशक, अर्बन एस्टेट हरियाणा, पंचकूला के मैमो न0 A-8.2017/1639 दिनांक 28.07.2017 व कार्यालय महानिदेशक,रा0चौ0ब्यूरो (ह0), पंचकूला के पत्र क्रमांक 9586/1-6/SVB(H) dated 31.07.2017 के अनुसार गांव चौकी, तहसील व जिला पंचकूला की एक्वायर भूमि की लगभग 60 करोड़ रुपये एक्सेस पैमेन्ट करने बारे, श्री एम0एस0 सांगवान भूमि अधिग्रहण अधिकारी, धूप सिंह नायब तहसीलदार, जैनाराम पटवारी व कमल नैन सैक्शन ऑफिसर व भू-मालिकों के विरुद्ध अभियोग दर्ज करने बारे आदेश प्राप्त हुए है जिसका मजबूत इस प्रकार है :- निवेदन है कि गांव चौकी तहसील व जिला पंचकूला की एक्वायर भूमि का अधिक भुगतान करने के सम्बन्ध में मुख्य प्रसाशक हुडडा] पंचकूला ने जांच के लिए मुख्य लेखाधिकारी, भूमि अधिग्रहण अधिकारी व सहायक उप जिला न्यायवादी हुडडा विभाग पंचकूला की कमेटी गठित की थी। कमेटी की जांच रिपोर्ट का सार निम्नलिखित है:- Land measuring 274.96 Acres falling in revenue state of three village of District Panchkula (Chowki, Bir Ghaghar and Nada) were notified under Section 4 of the Land Acquisition Act, 1894 on 26.6.1998 for development of land for recreational, public and semi-public, for Sector 32, Panchkula by Haryana Urban Development Authority Similarly, the notification under Section 6 of Act dated 23.6.1999 was issued. An Award No. 2 was announced on 30.07.2003 for area measuring 224.28 acres including the land comprised of Village Chowki.

**I.I.F.-I (एकीकृत जाँच फार्म-I)**

It is submitted that 14971 Biswa (155.95 Acres) of Shamlat Land was notified for acquisition vide notification issued Under Section 4 and 6 of Act out of the total Shamlat Land of the Village measuring 30344 Biswa (316.08 Acres). That out of 14,971 Biswa which was acquired from the total 7 shares of Village Chuwki, Tehsil and Distt. Panchkula, the share of 4 ½ co-sharer was undisputed and originally decided by the then Asstt. Collector, Panchkula and their compensation was released by the Land Acquisition Officer, Panchkula on the basis of Award dated 30.7.2003. Since there was inter-se dispute between the co-sharers of 2 ½ shares, so the entire compensation of the inter-se disputed land of 2 ½ shares was referred alongwith compensation by the Land Acquisition Officer, Panchkula to the reference Court for the purpose of apportionment and enhancement. The total land of the proprietors was originally 1664 Bigha 8 Biswa (33288 Biswa) and after consolidation and utilization/transfer of common purpose land in favour of Panchayat the in the ownership of proprietary body remained only 1517 Bigha 4 Biswa (30344 Biswa) out of which 2 ½ share from the total 7 shares comes to 541 Bigha 17 Biswa (10837 Biswa), as decided by Sh. Rajesh Garg, Ld. Additional District Judge, Panchkula vide order dated 24.1.2014 for the purpose of division between the proprietor of 2 ½ shares as under:-

It is submitted that the Land Acquisition Collector in terms of Award dated 30.7.2003 assessed the market value of the acquired Land at Collector rate i.e. Rs. 4.00 Lacs per Acre which included the compensation of land, building, trees and 30% solitum in view of acquisition and additional amount @12% per annum. The reference u/s 18 and 30 of Land Acquisition Act 1894 was filed before the Court of Ld. A.D.J., Panchkula which were allowed on 24.1.2014 with costs and market value of the Land was determined @Rs. 662/- per Sq. Yrd. On the care of notification u/s 4 of the Act dated 26.6.1998. The petitioners Land owners were entitled to statutory benefits u/s 23 (1a) 23 (2) and 28 of the Land Acquisition Act.

In view of award passed by the hon'ble Court of ADJ, Panchkula on 24-1-2014 Land Acquisition Officer, Panchkula submitted the claims of Sh. Devinder Singh etc., Jasvir Singh etc., Hukam Chand etc. and Resho Devi vide his letter No. 5274 dated 3.12.2014 and claims of remaining petitioners/land owners viz Harmala Kaur Rattanmala Kaur, Bant Singh etc., Daljit Kaur etc. and Desraj etc. vide letter No. 452 dstd 5.2.2015. The calculations of enhanced compensation were made of the total shares of Shamlat Deh Land and award payments were also shown on the total shares of Shamlat Deh Land. At the time of submitting the case it is also certified by the Land Acquisition Officer, Panchkula that possession of the land mentioned in calculation sheet has been handed over to HUDA and it was also stated by the Land Acquisition Officer, Panchkula that the claims have been duly checked by the section Officer, deputed in their office. The date bound demand letters were sent by the Land Acquisition officer, Panchkula to release the claimed amount of enhanced compensation as the executions were pending in the Court of ADJ, Panchkula. The following amount were sanctioned on the basis of calculations sheets submitted by the Land Acquisition Officer, Panchkula after checking the calculations on the basis of entitlement of and area as certified by the land Acquisition Officer, Panchkula :-

The facts regarding actual acquired Shamlat Deh land of 2 ½ shares have been got verified from Sh. Rajbir Singh, Kanungo who is presently dealing the instant case and the case was examined on the basis of record submitted by Sh. Rajbir Singh, Kanungo o/o land Acquisition Officer, Panchkula and it was observed that payment of enhanced compensation pertaining to 2½ shares of acquired shamlat Deh land was to be released because 14971 Biswa (754787 Sq. Yrd.) of Shamlat Deh land was notified for acquisition vide notification issued under Section 4 and 6 of Act out of the total Shamlat land of the Village measuring 30344 Biswa (1529841 Sq. Yrd.) accordingly 2 ½ shares of acquired Shamlat Deh land are worked out on the proportionate basis of total shamlat Deh land as under :-

As per the above calculations, made on the basis of record/ information provided by concerned Kanungo Sh. Rajbir Singh o/o Land Acquisition Officer, Panchkula, an amount of Rs. 64,04,36,232/- (Say Rs. 64.04 Crores) was payable for the acquired land area but an amount of Rs. 124,11,78,150/- (Say Rd. 124.12 Crores) was paid to the land owners due to which an amount of Rs. 60,07,41,918/- (Say Rs. 60.07 Crores) has been paid excess which id to be recoverable form the concerned Land owners alongwith 15% interest thereon. As reported by the Land Acquisition Officer, Panchkula an amount of Rs. 15,86,88,298/- has been recovered from Smt. Harmala Kaur Rattanmala Kaur and now an amount of Rs. 51,09,02,584/- (Including interest upto 31.10.2015) is still required to be recovered from the concerned land owners and responsibility of the concerned officers/officials at fault of the office of the Land Acquisition Officer, Panchkula is also to be fixed and strict action is also to be initiated against them as per rules because claims of enhanced compensation were prepared by Sh. M.S. Sangwan, L.A.O., Sh. Dhooop Singh, Naib Tehsildar, Sh. Jaina Ram Patwari and Sh. Kamal Nayan, S.O. by concealing the facts of actual payments of award and actual acquired Shamlat Deh land pertaining to the land owners of above said 2 ½ shares of Shamlat Deh land as intimated by Sh. Rajbir Singh, Kanungo that an amount of Rs. 3,51,86,579/- was deposited in the Court on 9.9.2004 by filing reference u/s 18 and 30 of Land Acquisition Act 1894 before the Court fo Ld. A.D.J., Panchkula which were allowed on 24.1.2014 and this amount was calculated on the basis of actual acquired Shamalt Deh land but the calculations of previous payments were shown on the increased land area due to which neseccary approval was obtained by concealing the facts. On the perusal of relevant record it is also found that no appeal (RFA) has so far been field in the Hon'ble High Court by the Land Acquisition officer, Panchkula against the orders dated 24.1.2014 of Ld. ADJ, Panchkula which was required to be filed within the stipulated period. The concerned land owners have been paid the enhanced compensation of more then Rs. 60.00 Crores for the area which is still in their possession and not acquired by the Govt. by concealing the facts by the concerned officials of Land Acquisition Officer, Panchkula. Keeping in view the position explained above it is concluded that action of the office of land Acquisition Officer, Panchkula is totally fraudulent and a clear cut loss on the State exchequer due to which an huge amount of more than Rupees 60.00 Crores of Govt. money was paid excess to the land owners which is to be recovered along with interest immediately and strict action is required to be taken in this regard. सरकार के अनुमोदन उपरान्त महानिदेशक अर्बन अस्टेट हरियाणा पंचकूला के मैमों नं.
