Memo No. 6/4-2013-HRL(4) dated Panchkula 04/09/15 Subject: For initiating legal action by registering the Criminal Cases. Kindly refer to the subject cited above. A requisition to fill up the post of PGTs in various streams was sent by the department of Secondary Education to the Haryana School Teacher Selection Board, PanchKula in the year 2012, in pursuance to the Haryana State Education School Cadre (Group-B) Service Rule, 2012. As per Note 1, Appendix-B of the Rules, 2012, an exemption from passing HTET was provided to those candidates who have 4 years teaching experience to their credit. Accordingly, the Haryana School Teacher Selection Board, Panchkula, made the recommendations of those candidates also, who appeared before the Board, on the basis of their teaching experience. While recommending the names of selected candidates, the Haryana School Teacher Selection Board, Panchkula had made the following observations:-"The selected candidates have not been medically examined and no special enquiry in to their antecedents have been made. The documents pertaining to their qualifications, 4 Year Experience, age, caste/category and Universities as claimed by them in the application from may please be got checked/verified from the issuing authorities, before they

are allowed to join their duty. A copy of the appointment letter issued to the candidates may also be endorsed to the Board." In view of the above observations of the Haryana School Teacher Selection Board, Panchkula different committees were constituted to verify the experience certificates and other documents of the selected candidates. The teaching experience of the above selected candidates have been got verified by the document verification committee on the basis of attendance register, A-roll register (payment of salary through bank/EPF deduction etc.), number of students appeared in the board exam (as obtained from Board of School Education Haryana, Bhiwani) and other relevant documents and these committees have reported that teaching experience of these candidates seems to be totally unreasonable, unjustifiable and wrong. Due to this irrational and manipulated approach of these school authority/Management in issuing teaching experience certificates based on manipulated record/by creating new record to help some of the candidates, had led to a situation where instead of one experience certificate multiple experience certificates have been issued by fabricating the relevant record. The detail of the selected candidates on the basis of teaching exprinces issued by the schools concerned and the number of the student appeared in the board exam for different years is annexed here with as annexure A-1(83 Candidates). From above details it becomes amply clear that these school managements issued multiple number of experience certificates in one subject knowing fully well that there are very less number of students in these subjects. On the basis of these manipulated teaching experince certificates issued by the school management concerned these candidates have got their recommendation from haryana School Teacher Selection Board and these candidates are demanding appointment letters. Thus it can be clearly that the Managment /Principals of these school have played fraudulent act by preparing fresh record/tempering and creating the new record to befool the authorities/Government for obtaining appointment as PGT for these candidates. It is therefore requested that a legal action may kindly be initiated by registering the criminal case against the school authorities. List of 83 PGTs candidates is enclosed. Apart from this, if vigilance Department desires to enquire in to the genuineness of experience certificates in respect of other candidates, the same may also be done in the interest of justic and fair play.
