Dear Sir,I have got an order of the Director General, S V B(H) Panchkula vide his office endst. No. 8645/I-1 dated 22-06-2015 and Chief Secretary to Haryana Govt. Haryana, Vigilance Deptt. memo No. 26/23/15-2VI dated 12-06-2015 with the direction to register the criminal case on the technical opinion provided in special checking for the work of construction of the building for Centre of Excellence (COE) in ITI at Gohana in district Sonapat (including E.I and P.H Services) against Sh. Anil Kumar Sahrawat, contractor, Sh. Suresh Dangi, E.E., Sh. R.C. Stijja, S.D.E., Sh. Surinder Deswal, S.D.E., Sh. Ram Chander, S.D.E. and Sh. P.C. Chitra, J.E related to PWD, B&R Deptt. Gohana(Sonapat). Sh. V.K. Kamboj, Executive Engineer, SVB(H) Panchkula conducted technical examination vide order no. Nil dated 9-07-13 of Director General, SVB, Haryana, Panchkula opining therein, "Hence, total=38+33+85=156 cement bags have been found less consumed at site costing @ Rs. (175+3%) i.e. Rs. 180.25 per bag = Rs. 28,119/- which at penal rate costs Rs. 56,238/- which may be recovered from Sh. Anil Kumar Sehrawat, Contractor and suitable departmental action is recommended against Sh. Suresh Dangi, E.E., R.C. Stijja, S.D.E., Surinder Deswal, S.D.E., Ram Chander, S.D.E. and P.C. Chitra, J.E. for this lapse/loss. As a result of cement plaster and cement mortar are on inferior side and variation in results is more than 5%. The Superintending Engineer, Incharge may ensure the stability of structure as per PWD specifications." On this technical report Chief

Secretary to Govt. of Haryana Vigilance Deptt ordered registration of a criminal case against above mentioned persons.
