Sir,

A reliable source information was received against Sh. Sudhir Parmar who is posted as Special Judge for CBI and ED cases at Panchkula containing allegations of showing be favourism to the accused persons namely Sh. Roop Bansal his brother Basant Bansal, the owners of M3M and Lalit Goyal, the owner of IREO group in lieu of undue advantage as criminal cases of Enforcement Department (ED) under PMLA other cases of CBI are pending against the above accused persons in his Court. The reliable source information disclosed the following instances of grave misconduct, abuse of official position and demand/acceptance of undue advantage/bribe from the accused persons in cases pending in his court:-

- 1. A case was registered under the Prevention of Money Laundering Act (PMLA) by the Enforcement Directorate (ED) in the year 2021 and accused Lalit Goyal, the Vice-Chairman and Managing Director of realty giant IREO Group was arrested in November 2021 in the said case pertaining to cheating and siphoning of funds of home buyers and others. The said matter is pending in the court of Sh. Sudhir Parmar vide No. COMA/01/2022 Directorate of Enforcement Vs Lalit Goyal others.
- 2. The source has provided screenshots of whatsapp chats between Sh. Sudhir Parmar and another person through his own mobile phone as well as that of his nephew Ajay Parmar, wherein he demands Rs. 5-7 Crores for helping the said owners of M3M in ED cases and requests the other person chatting with him to receive bribe money on his behalf from them. In the same chat, the other person states that Rs. 5 Crores have already been given to Sh. Sudhir Parmar by the accused of IREO case. Copy of the whatsapp chat is enclosed.
- 3. As per the source information, before his posting as Special Judge, CBI/PMLA court Haryana at Panchkula, Sh. Sudhir Parmar was posted as ASJ/ADJ at Gurugram, where by abusing his official position of being a Judge, he got in contact with the owners of M3M and IREO group and got undue favour by getting appointed his nephew Sh. Ajay Parmar (@ Amrit) as a Legal Advisor in M3M at a package of approximately Rs. 12 Lac per annum. Subsequently, when Sh. Sudhir Pramar was transferred as Special Judge of CBI ED, Haryana at Panchkula, the annual package of his nephew was straightway hiked to Rs. 18-20 Lacs and Sh. Sudhir Parmar being CBI/ED Special Judge, in connivance with the accused persons started favouring them for the sake of illegal gratification through his said nephew. These facts are disclosed in the recordings provided by the source labelled as recording No. 1, 2, 3 4, copies of which alongwith transcripts are enclosed.
- 4. In another audio recording provided by the source, Sh. Sudhir Parmar is asking someone for Rs. 1.5 Crores (50-50 Lac per head) as illegal gratification for meeting with the accused persons. Copy of the audio recording No. 5 along with its transcript is enclosed.
- 5. In three other recordings provided by the source, Sh. Sudhir Parmar is speaking with Roop Bansal and says that he is afraid of his connectivity with the accused persons being disclosed due to sensitive nature of his posting and he further tells him that he never talks to him (Roop Bansal) on his personal mobile phone and always speaks with him and other accused persons of M3M and IREO through mobile phone or whatsapp/Facetime from the phone of his nephew Ajay Parmar who is working in M3M group. Similarly, Roop Bansal also tells him that they also never talk to him directly on phone and they always talk to him through phone of his nephew Ajay Parmar. These facts are disclosed in Recordings No. 6, 7 and 8 provided by the source. Copy of which alongwith transcripts is enclosed.
- 6. More audio recordings provided by the source reveal that Sh. Sudhir Parmar during conversation with an unknown person, admits/claims that he did not let Roop Bansal become an accused in ED cases. In another recording with Roop Bansal, the owner of M3M, he even promises that if he (Roop Bansal) is let off in the CBI case, then he (Sudhir Parmar) would not let him (Roop Bansal) become accused in ED case. In another recording pertaining to property worth Rs. 1200 Crores, Sh. Sudhir Parmar claims that he has spoken to Sunil Yadav (Officer of ED) and he would not allow it to be attached provided some justification for the transaction of money is shown. The said facts are disclosed in recordings No. 9, 10–11, copies alongwith transcripts of which are enclosed.
- 7. In yet another recording, Sh. Sudhir Parmar, Special Judge states that he met the wife of accused Lalit Goyal his Brother-In-Law Sudhanshu Mittal and assured them that although he cannot release Lalit Goyal on bail in PMLA case, yet he would favour him by dealing with him in the court in a respectful manner and not harass him by issuing frequent Warrant/notices, or denying permission to visit abroad, etc and make him feel at home while in court. The said facts are disclosed in the recording No. 7, copy of which as provided by the source alongwith transcript is enclosed.
- 8. In addition to the above instances of criminal misconduct, the audio recordings also contain conversation of Sh. Sudhir Parmar with one VP Gupta (a removed/dismissed Judge of Haryana) wherein, they are making strategy to show favour with a view to extort money from Sh. TC Gupta, IAS (since retired), then Director Town and Country Planning, Haryana who apparently is an accused in some case of CBI/ED. The said facts are disclosed in the recording No. 12, copy of which along with transcript is enclosed.

In view of the above, a prima facie case under section 7, 8, 11 and 13 of Prevention of Corruption Act. 1988 and section 120 of IPC is made out against Sh. Sudhir Parmar, Sh. Ajay Parmar, Sh. Roop Bansal and other unknown persons. In this regard, the Hon'ble Chief Justice, High Court of Punjab and Haryana was requested to grant the necessary permission for registration of case vide letter No. 3089/ACB/(H) dated 21.02.2023. The permission has been accorded by the Hon'ble Chief Justice of the Hon'ble High Court, Punjab and Haryana, Chandigarh.

It is therefore, requested that a criminal case under section 7, 8, 11 and 13 of Prevention of Corruption Act. 1988 and section 120-B of IPC may be registered against S/Sh. Sudhir Parmar, Ajay Parmar, Roop Bansal and other unknown

persons.
