12. First Information contents (प्रथम सूचना तथ्य):

To, The Station House Officer, State Vigilance Anti Corruption Bureau, Faridabad. Sir, During the investigation of FIR No. 11 dated 24-3-2022 u/s 166,167,201,218,406,409,120-B IPC 13(1)(d) R/w 13(2) PC Act PS SV ACB Faridabad, it has surfaced that fake work orders for providing and laying of interlocking tiles on the berm of RMC road at Tigaon Road, Ballabgarh was awarded to Satbir Singh contractor on 27.11.2018 by Municipal Corporation Faridabad. The work was split in to 13 parts and in all the 13 fake work orders, the original estimates were revised/enhanced substantially within 20 days by the MCF Officials in connivance with Satbir Singh Contractor and payments have been made to the Contractor with the intention to embezzle the Government funds arising out of the payment of all the 13 fake work orders and cause undue benefit to the contractor. The details of all the 13 fake work orders are as below:

- It has been further revealed in the investigation of MCF cases with ACB/FBD that the work orders mentioned above have not been issued by the MCF Ballabgarh Division IV to Satbir Singh Contractor. Dispatch register of Ballabgarh Zone was also checked and it was found that there is no mention of the date 27.11.2018 in the register and the last dispatch number for the year 2018 is Sr. no 1424 dated 31.12.2018 related to relieving of Sh. Udham Singh (Apprentice Electrician), whereas number mentioned in fake work orders are 1431, 1432, 1435, 1446, 1448, 1437, 1441, 1454, 1460, 1453, 1461, 1462 1434. Hence it is clear that fake work orders were prepared and fake dispatch numbers were given. It has also been clarified from other departments of MCF (Namely divisions, II, IIIV) that these work orders were never issued from there also. The details of the fake work orders and their issuing date and numbers and their original estimates have been collected from the 1st Running Bills and MW-14 records. It was revealed that while preparing the 1st running bills, Assistant Engineer Sher Singh (now deceased) and Executive Engineer Prem Raj Singh from Engineering Branch put their signatures. It is also revealed that Prem Raj Singh Executive Engineer was not posted in Ballabgarh division of MCF and was transferred to Hissar on 24-01-2019 when the 1st running bills were passed for payment. The 1st running bills were also signed by Superintendent Vinod Kumar and Officer Incharge Accounts (OIA) Vishal Kaushik. The bills were further pre-audited by RSA Naveen Kumar and Joint Director Audit Mr. Hargulal. The amounts were credited in the account of the accused contractor Satbir Singh on the basis of these forged work orders

that were never issued and for works that were never done. It is further revealed from the MW 14 (Measurement of Works Register) that the details of all the payments made on the work orders for the 1st Running Bill has been entered including the enhancements made on the same. All the alleged 13 fake work orders were shown to be issued on 27.11.2018 and the enhancement of the initial estimates for the works indicated against each work order were shown to have been approved on a single day i.e. 8.12.2018, i.e. within a period of 20 days of alleged issuance of the work orders. It seems to be an organized crime. It is also worth mentioning that in all the 13 alleged fake work orders, the enhanced payment against each of them as indicated in the chart above was deliberately kept below Rs. 1.00 crore, so that fresh administrative approval need not be obtained, as per Rule 8 of Haryana Civil Works Rules 89.3.7 of Haryana PWD Code, but dealt at the level of Commissioner MCF. In this regard the approval for registration of FIR and permission u/s 17A PC Act has been received from the Haryana Government Chief Secretary's office Vigilance Department vide office order No. 52/22/2019-5VII dated 04-8-2025. Thus the acts of commission and omission by the officials of Municipal Corporation Faridabad namely Prem Raj Singh, Executive Engineer Engineering Branch, MCF (A-1), Vinod Kumar Superintendent MCF (A-2) Vishal Kaushik Officer Incharge Accounts (OIA) MCF(A-3), Naveen Kumar RSA MCF (A-4), Mr. Hargulal Joint Director Audit MCF (A-5), Smt. Sashi Arya, Supdt. MCF (A-6), Naveen Ratra, Clerk MCF (A-7) in connivance with Satbir Singh Contractor (A-8) have caused loss to the govt. exchequer to the tune of Rs. 12,18,71,165/- on the basis of above mentioned fake work orders which were never issued and for works that were never done. The officials of MCF as stated above entered into a criminal conspiracy with each other and also with Contractor Satbir Singh pursuant to which they dishonestly and fraudulently by abusing their official position cheated the Government and thus caused substantial loss to the Government and the all above accused committed the offence under 166,167,218,406, 409,420,467,468,471,120-B 201 IPC and Section 7 R/w 2(i) 13(1)(a) R/w 13(2) of Prevention of Corruption Act 1988. The tehrir is submitted for registration of FIR, upon registration, a special report be forwarded to the Illaqa Magistrate and the higher authorities concerned in compliance with the law, another competent Investigating Officer be also appointed to conduct the further investigation of the case.
