3. The above approval is subject to the following conditions:-

- That an article of stores/goods shall be purchased from the above approved source only if its price is up to the one provided in the Rate Contract, if any, arranged by DS&D, or market price, whichever is less.
- That the category of the item as at Para-2 Column-2 is not made an approved item. The HKVIB will provide standard specifications of all the said items and it will be the item with standard specification which will be an approved item.
- That the fixing of rates of each item and the period for which such rates will be in force will be decided by the Standing Committee on Pricing & Quality Control as constituted by State Government Order No. 6/1/2009-4BII dated 22.09.2010.
- That a maximum threshold limit for making procurement of stores/Goods from an Approved Source as detailed above is Rs.1 Lakhs in each case (without splitting of orders). Any procurement beyond Rs.1 Lakh may be as per the normal e-Tendering process as prescribed in relevant purchase rules of the State.

- (v) That the orders for the purchase will be directly placed with the Approved Manufacturing Unit for the relevant approved items with a copy of the same to Haryana Khadi and Village Industries Board (HKVIB), Bays 63-66, Sector-2, Panchkula, Haryana.
