Integration of Govt. Departments/Boards/Corporations etc with State Bank of India (SBI) for Online Payments (e-Service Fee, Tender Fee, EMD) on the NIC e-Procurement Portal (etenders.hry.nic.in).

On the subject cited above, I have been directed to convey as under:-

- That in order to provide uniformity of processes, this office vide Memo No. DS&D/Admin/NIC Portal/2018/Spl-1/ dated 28.12.2018 approved State Bank of India (SBI) for providing Online Payment Solution for the NIC e-Procurement Portal (etenders.hry.nic.in). The SBI was directed to ensure implementation of e-Payment Solution on immediate basis i.e. within a week.
- 2. That the State Government vide its Memo No. DS&D/Admin/eProc/2018-19/2222-2410 Dated 14.05.2019 had decided that all the Govt. Departments/ Boards/ Corporations/ Universities/ Agencies etc who were at that time on-board on the State Single e-Procurement Portal (haryanaeprocurement.gov.in) will migrate on NIC e-Procurement Portal (etenders.hry.nic.in) w.e.f 20.05.2019.
- 3. That the process of integration of all the Govt. Departments/ Boards/ Corporations/ Universities/ Agencies etc with the State Bank of India (SBI) for ensuring Online Payment Solution (e-Service Fee, Tender Fee, EMD) is taking time and affecting the tendering process of different Department/Boards etc which are already under urgency of pending works (due to Model Code of Conduct) and further State Government Initiatives for completing all works related to normal working/announcements of the State Government. Presently, all the tenders being uploaded on the NIC Portal are in Offline Payment Mode.
