I am directed to invite your kind attention to the Govt. Order No. 2/7/2014-4IBII dated 01.12.2014 and Order No. 2/7/2014-4IB-II dated 07.07.2017 on subject cited as above.

2. Vide the order dated 07.07.2017, in Para-2 of Notification No. 2/7/2014-4IBII dated 01.12.2014, the contents- '*In case of Departments under the charge of the Chief Minister, the concerned Administrative Secretary would attend the meeting*' were amended/ substituted to the extent that '*Chief Minister Haryana/ Education Minister Haryana shall chair the meeting of HPPC in respect of the cases pertaining to the Indenting Departments whose Ministers-in-Charge they respectively are.*'

The matter has been reconsidered by the State Government and now, it has been decided that the contents '*Chief Minister Haryana/ Education Minister Haryana shall chair the meeting of HPPC in respect of the cases pertaining to the Indenting Departments whose Ministers-in-Charge they respectively are.*' of the notification No. 2/7/2014-4IB-II dated 07.07.2017 is hereby amended/ substituted to the extent that '*Chief Minister Haryana shall chair the meeting of HPPC in respect of the cases pertaining to the Indenting Departments whose Minister-in-Charge he himself is.*'
