No.2/2/2016(1) - 4IB-II -The matter regarding rationalization of purchase of vehicles required by various Government Departments/Agencies was under consideration of the State Government since some time. The matter has been considered by the State Government and the following amendments/substitutions are made in the relevant portion of Para-9 of Government Order No. 2/1/2004-4IB-II Dated 06.05.2005 as detailed below:-

"The purchase of vehicle required by various Govt. departments/Agencies as per entitlement as contained in Govt. instructions issued by Chief Secretary to Govt. Haryana from time to time will be purchased on GeM and are taken out from the preview High Powered Purchase Committee. Further, the vehicle as required by Ministerial car section Govt. of Haryana for ministers and other state dignitaries are to be purchased and decided at the level of Administrative Secretary to Govt. Haryana, Transport Department subject to the condition that it will have a limitation that (i) the total expenditure on account of this should not exceed Rs.1 Crore per month and (ii) maximum two number of such vehicles can purchased per month. In case of purchase of remaining vehicles, the existing instructions of clubbing the indents of Govt. Departments/Boards/Corporations and then getting the purchase decided from High Powered Purchase Committee will remain continue"

This issues with the concurrence of Finance Department conveyed vide their U.O. No. 1/38/2016-4FD III/19/18714 of dated 19.07.2019.
