Committee constituted Vide Govt. Order No. 2/1/2015-4I B-II dated 04.06.2015 to decide the appointment of Consultant for various kinds of Consultancy Assignments- Expanding the Scope of Work.

The State Government vide its order No. 2/1/2015-4I B-II dated 04.06.2015 had constituted a committee to consider and decide/ approve the proposals for engagement of Consultants for various kinds of consultancy assignments. Further, the State Government vide its order No.2/2/2016-4I BII dated 29.08.2016 revised the financial power of the said committee for Appointment of Consultant involving a financial outgo from below Rs.50 Lakhs to financial outgo below Rs. 1.50 Crores.

The matter regarding expanding the Scope of Work for the above referred committee was under consideration of the State Government from some time and having considered the same, the Government has decided that the following content is added in respect of scope of work in the Government notification No. 2/1/2015-4I B-II dated 04.06.2015:-

"The above committee will also be the competent authority for finalizing the cases of procurement of Services required by various Govt. Departments/ Govt. Agencies as per the financial competencies decided by the State Govt. from time to time"
