In case, the Principal Secretary, Industries & Commerce is not able to attend the HPPC meeting due to emergent situation, then Director, Supplies & Disposals, Haryana in addition to his own duty will also represent Principal Secretary, Industries & Commerce as the member HPPC and vice versa.
