NOTIFICATION

No. 2/7/2006-4IBII - Dated the 29th of June 2011

The Directorate of Supplies & Disposals is mandated to process the procurement of stores for various Government Departments/ organizations in accordance with the rules on the subject and the provisions contained in the Manual for which there exists an institutional mechanism with the constitution of the High Powered Purchase Committee (HPPC) at the apex level. However, of late, the need for 'procurement of services' has increased manifold in a dynamic economic environment with the increased focus on implementation of e-Governance initiatives, and projects in the PPP mode. The procurement of 'consultancy services' for the PPP Projects and 'Consultancy and Turn-key Project Delivery Services' for the e-Governance Projects, which has become an imperative need, calls for a different set of procurement processes, which are at significant variance with the processes followed for procurement of goods.

2. Having taken note of the above, the Governor of Haryana is pleased to constitute a 'Special High Powered Committee' as an institutional mechanism for procurement of consultancy and allied services relating to PPP Projects and the e-Governance Projects involving a financial outgo of Rs. 50.00 lakh and above, as under:

i)	Hon'ble Industries & Commerce Minister, Haryana	Chairman
ii)	Chief Secretary to Government of Haryana	Member
iii)	Financial Commissioner & Principal Secretary, Finance & Planning Department	Member
iv)	Financial Commissioner & Principal Secretary, Industries & Commerce Department	Member
v)	Administrative Secretary of the concerned Department	Member

3. The Committee may co-opt any other subject expert(s) as special invitee(s).

4. While the committee would be serviced by the department concerned whose agenda/ proposal is placed for consideration/ decision, the PPP Cell in the FD would serve as the Secretariat in respect of PPP Projects and the IT Department would serve as the Secretariat in respect of IT/ e-Governance Projects.

5. The proposals below the above prescribed financial ceiling would continue to be processed by the Committee headed by the Chief Secretary in respect of PPP Projects as

per the PPP Policy and by the Technical Committee on IT in the case of e-Governance projects.

6. The 'Terms of Reference' of the Committee would be as under:-

i) To consider and approve the proposals for engagement of consultants for various kinds of consultancy assignments, e.g.:

- Diagnostic Study Reports;
- Pre-feasibility Reports;
- Detailed Project Reports;
- Strategic Consultancy Services;
- Transaction Advisory Services;
- Preparation of 'Request for Proposal' (RFP) Documents.

for projects of various departments/ organizations in the State, to be implemented in the public sector or in PPP mode.

ii) To consider and approve proposals involving engagement of consultants for preparation of RFQs, RFPs and engagement of System Integrators/ Solution Providers for undertaking service deliverables and implementation of IT/ e-governance projects on turn-key basis involving an expenditure of Rs. 50.00 lakh and above.

iii) To consider and approve the standardised structure of the bidding formats/ conditions for engagement of consulting services (i.e. pure financial bids or QCBS etc.), evaluation criteria and the methodology for technical evaluation in respect of infrastructure projects under the PPP mode/ e-Governance;

iv) To consider and approve panels of consultants/ consulting agencies for various purposes and prescribe the conditions for engagement thereof;

v) To consider and approve the final award of Projects in the above categories.

7. The Headquarter of the committee would be at Chandigarh and it shall hold its meetings as & when required.
