adopted as far as practicable, keeping in view the requirements of the indenting department.

4. The committee will fix the rates of each item and lay down the period for which such rates will be in force, provided that those rates may be reviewed before the expiry of that period for reasons to be recorded in writing.
5. The committee will meet at such intervals as may be required.
6. These orders will be applicable in all cases of approved sources.
7. These orders may please be brought to the notice of all concerned.
