The matter regarding the competencies for the finalisation of representation/grievance received from the bidders/firms as contained in order dated 25.07.2016 has been reconsidered by the State and it has been decided to insert Para-3 after Para-2 of the said order as under:-

"3. For ensuring natural justice in the Grievance Redressal Mechanism, the competencies for the finalisation of representation/grievance received from the bidders/firms will be as under:-

2	Procurement cases related to Goods/Stores, Services, Consultancy Services, Turnkey and all types of works valuing more than Rs.35 Lakhs to up to Rs. 1 Crores	Administrative Secretary to Govt. Haryana of the concerned Govt. Department/Agency
3	Procurement cases related to Goods/Stores, Services, Consultancy Services, Turnkey and all types of works valuing more than Rs. 1 Crores	A Committee as under:- (i) Administrative Secretary to Govt. Haryana Industries & Commerce Department - Chairman (ii) Director General, Supplies & Disposals - Member (iii) HOD of the concerned Govt. Department/Agency - Member Secretary
