Outsourcing of vehicles required by various Govt. Departments/ Boards/
Corporations/ Federations etc. across the State.

This is in continuation to this office Rate Contract no. 16/HR/E-3/2016-17/Part-II/7036-37 dated 23.07.2018 & No. 7680 dated 07.08.2018 and Extension letter (01 year) No. 69/HR/RC/E-3/2021-22/2749-2949 dated 17.06.2021, on the subject cited above.

It is to inform you that the clause no. 8.16 titled "Provisions for increase / decrease of the fuel prices" of Rate Contract of Outsourcing of vehicles is considered by this office and formula for calculating the increase/decrease of monthly charges w.r t. change in fuel prices is hereby amended and will be read as under:

"Increase/decrease in monthly charges = (Actual Distance Covered by the vehicle during the month ÷ Mileage of Vehicle) X increase /decrease of Fuel Rates (Fuel Rate on 1st day of Q2-(Minus) Fuel Rate on 1st day of Q1)".

Other terms & conditions of the subject Rate Contract will remain same.
