## ORDER

In compliance of memo No. TA(PP)/2021-22/1732-39 dated 29.09.2021 of Agriculture & Farmers Welfare Deptt., Haryana, HSDC floated re-tender on 28.09.2021 for procurement of fungicide for further distribution to the farmers along with wheat certified seed during Rabi 2021-22 sale season. Three bidders participated in the said e-tender i.e. M/s Shivalik Crop Science, M/s General Crop Science and M/s Radical Crop Science pvt. Ltd. and offered Tebuconazole 2% DS fungicide 40 gm pouches as required in re-e-tender. As per terms and conditions of the DNIT, all the three bidders were found eligible in technical bid and financial bids were opened after obtaining the approval of the Competent Authority. M/s Radical Crop Science Pvt. Ltd. was found as L-1 as per rates received in the financial bid. Accordingly, tender committee negotiated with M/s Radical Crop Science Pvt. Ltd. and recommended to purchase the Tebuconazole @Rs.14.99 per pouch of 40 gram.

On 18.10.2021, M/s Radical Crop Science Pvt. Ltd. informed that the factory production has faced a fresh set of production problems and therefore they will not be able to supply the Tebuconazole material in the short span of time. Hence they withdraw their offer.

Meanwhile, a complaint dated 18.10.2021 was received from another bidder i.e M/s General Crop Science Pvt. Ltd. with regard to documents submitted by M/s Radical Crop Science Pvt. Ltd. for Tebuconazole 2% DS 40 gram pouch. Further in compliance of orders of W/ACS vide the matter was forwarded to Govt. of Haryana, Agriculture & Farmers Welfare Department. Further, as per orders of the worthy ACS, the matter was enquired/ examined by the Director General, Agriculture & Farmers Welfare Department and report was submitted vide Memo No. 1074 dated 12.05.2022. During the examination, they found that the letter No. 9572-END/2019 dated 06.03.2019 regarding endorsement of additional packing of Tebuconazole 2% DS in 40 gm in respect of Certificate No. CIR-150536/2018-Tebuconazole (DS) (387)-659 submitted by M/s Radical Crop Science Pvt. Ltd. to HSDC during e-tender was examined through Govt. of India, Ministry of Agriculture & Farmers Welfare, Central Insecticide Board & Registration Committee, Faridabad. The Central Insecticides Board & Registration Committee, Faridabad informed that the file/ SCN Number does not match and the copy of the endorsement letter dated 06.03.2019 was not genuine and was not issued by their office.

Ltd. on account of submission of false/ fabricated documents in re-tender process of HSDC.

Keeping in view of the facts and report received from the Agriculture & Farmers Welfare Deptt., Haryana, it was found that M/s Radical Crop Science Pvt. Ltd. not only violated the terms and conditions of the re-tender, but they also mislead the Corporation by producing false and fabricated documents. Therefore, I hereby order to blacklist M/s Radical Crop Science Pvt. Ltd. from engaging in business with HSDC for a period of three years from the date of issuance of this order. The EMD of rupees two lakh deposited by M/s Radical Crop Science Pvt. Ltd. on account of participation in the said tender shall also be forfeited.
