1. **Place of delivery:-** Ambala, Haryana
2. **F.O.R. :-** The above rates are FOR destination basis at supplier's risk.
3. **GST :-** Inclusive in above rates.
4. **Freight Charges :-** Inclusive in above rates.
5. **Delivery Period :-** 90-120 days from the date of placement of Supply Order.
6. **Payment :-** 90% payment in advance & balance 10% after physical delivery of inspected/ accepted vehicle at destination.

7. Warranty :- 3 years or 1,00,000 Kilometers whichever is earlier.
8. Free Service :- 3 nos. labour free services
9. Penalty clause :- As per the GeM T&C
10. Billing :- M/s Mahindra & Mahindra, Kandivali (Maharashtra).
11. Inspection :- The Indenting Deptt. may decide to get the vehicle inspected at his own level or from any other inspection agency before taking delivery of vehicle at dealer premises M/s KBS Motors, Ambala (Haryana).

In case, the vehicle offered for inspection by the firm fails to meet the specifications stipulated in NIT/Order are rejected by the Inspecting Committee, the Indenting Department will have the right to levy a penalty at 0.1% of the total order value. In case, the vehicle offered for inspection fails during the 2nd inspection also, the Indenting Department will have the right to increase the penalty to 0.25% of the total order value. In case, the vehicle offered fails during the 3rd and final inspection also, the firm will be liable for penal action including forfeiture of security, risk purchase, debarring/ blacklisting in future, and no further opportunity for inspection would be provided to the supplier firm.

12. PRICE FALL CLAUSE :- The price charged for the stores shall not exceed in any way the lowest price at which you quote/supply the stores of identical description of stores to DGS&D, New Delhi/State Govt./Central Govt./Institutions/ undertaking/ GeM any other person during the delivery period/ currency period of the rate contracts. If at any time during the delivery/currency period, you reduce the rate, sale price of quoted stores to any person at the price lower than the price chargeable under this supply order/contract, you are required to inform this office and price payable under the supply order/contract for the stores supplied after the date of coming into force of such reduction of rates shall stand correspondingly reduced to that level. You shall promptly notify the reduction of rates to this office as well as to concerned Indenting Officers/ Consignees. You shall also give a certificate on your bills that the rates charged by you are not in any way higher to these quoted to the DGS&D/GeM, New Delhi and other State Govt. Central Govt. Institutions etc. during the corresponding period. The Indenting Officer shall be required to ensure that requisite certificate is given by the concerned firm on the bills before releasing their payments. Full benefit due to reduction in DGS&D /GeM rate contract or Net Dealer Price during the period of rate contract/ supply will be passed on to the consignee in addition.
14. Failure to effect supply within stipulated period or repeatedly offering supply liable for rejection may render to penal action as per rules.
15. In case of non supply or any breach of this contract, penal action would be taken & agreed by you vide quotation letter dated 24.11.2022 and letter no. M&M/DGS&D/Proc./HPPC/142 dated 15.12.2022.
