Ltd. or Ltd.) or proprietorship firm can participate who have valid GST Registration Certificate/Sales Tax (VAT) Registration Certificate/Tax Identification No. (TIN) issued from the Competent Authority. Copy of GST Registration Certificate/Sales Tax/VAT Registration Certificate should be attached with the tender (bid).
2.	PAN Card of the firm/proprietor & the copy of the same should be submitted with the tender.
3.	Undertaking on the letter pad/ letter head in case of firms (Pvt. Ltd. or Ltd.) & affidavit on Non Judicial Stamp Paper of Rs. 10/- duly attested from Notary Public in case of proprietorship firm to the effect that the firm/person is neither black listed by any Government Department, nor any criminal case/complaint is registered or pending against the firm/person.
4.	Note:-All copies to be attached should be self attested/certified.

IMPORTANT TERMS AND CONDITIONS

 - (2) Under this process, online Price Bid/ Quotation shall be invited at Single Stage under One Cover i.e. Commercial Envelope. The bidders have to submit online Financial (Commercial) Bid at Single eProcurement Portal (<https://etenders.hry.nic.>) under the category:Disposal tenders. Bidders also have to upload the requisite documents as mentioned in the eligibility criteria while submitting the online Financial (Commercial) Bid.
 - (3) The Price Bid under the Commercial Envelope shall be opened for only those bidder(s) who has remitted Security Amount i.e. 10% of the Rate (Sale Value of the Store) quoted by the bidder (Rounded off to Rs. 100/-) online towards their e-Challan & duly verified at Single eProcurement Portal.
