- F.O.R.:- The above rates are F.O.R. destination basis upto designated division level
  Government Veterinary Hospitals i.e. Ambala City, Gurugram, Hissar, Rohtak,
  Karnal and Faridabad and shall include all expenses including packing,
  transportation, handling etc.
   GST: Inclusive is at an expense.
  - GST:- Inclusive in above rates.
  - DELIVERY PERIOD: Within -45 days from the date of issue of supply orders.
  - 4. PAYMENT TERMS:- 100% payment will be made within 30 days after physical delivery, inspection and acceptance of stores duly supported with satisfactory inspection and laboratory reports and after receipt of duly verified bills from the respective consignees. The Indenting Departments would have option to release payments in RTGS/ Electronics mode also.

Delay in payments to the suppliers beyond the stipulated credit period indicated in the supply order, unless supported by cogent reasons and approved by a higher authority, will attract penal interest on the defaulting amount @ Rs. 25/- per rupees one lakh per day of delay beyond the stipulated credit period. Non provision of adequate budget will be no ground for delay in payments to the supplier.

- INSPECTION:- The inspection would be carried out by the inspection committee formed by the Animal Husbandry & Dairying, Department, Haryana. In case, the material offered for inspection by the firm fails to meet the specifications stipulated in NIT/Order/Contract and the samples are rejected by the Inspecting Committee, the Indenting Department will have the right to levy a penalty at 0.1% of the total order value. In case, the material offered for inspection fails during the 2<sup>nd</sup> inspection also, the Indenting Department will have the right to increase the penalty to 0.25% of the total order value. In case, the material offered fails during the 3<sup>rd</sup> and final inspection also, the firm will be liable for penal action including forfeiture of EMD, risk purchase, debarring/blacklisting in future, and no further opportunity for inspection would be provided to the supplier firm.
  - 6. PENALTY TO FIRM ON DELAY IN DELIVERY: The contractor fail to deliver or dispatch 7. any consignment within the period prescribed for such delivery or dispatch stipulated in the supply order, the delayed consignment will be subject to 2% penalty per consignment per month recoverable on the value of the stores supplied. The other details will be as per provision contained in Sr. No. 14 of "Schedule-'B' Condition of Contract". 8.

The stores should be from fresh stock. The date of manufacturing of the stores shall not be older than 6 months on the day of supply. Similarly, the expiry date of the stores should not be less than one year on the day of supply of stores to the department.

9. The department or its representatives shall have the right to inspect the tendering firm including all its manufacturing and packing facilities to assess the capacity, eligibility, and quality standards etc. of the firm. All reasonable facilities and assistance, including access to relevant records and production data, shall be

The supplies shall be accompanied with in-house test reports of each batch including 10. certificate of Analysis, Material Safety data and report for the presence of major

After receipt of stores, random samples will be drawn for quality testing. These 11. samples will be got tested from any Government/ Government Approved/ NABL accredited laboratory at the discretion of the department for presence/quantification of major active ingredients. The cost of such testing shall be borne by the firm. The store shall be accepted only after receipt of satisfactory test report from the laboratory.

- During the shelf life, the supplied material may be subjected to further testing at any point of time at the cost of the department.
  - 13. In case, the material is found defective/substandard, the whole lot/ batch of supply will be rejected and the firm will be liable to replace the entire quantity or make full payment of the entire rejected stores irrespective of the fact that a part or whole of the supplied stores may have been consumed. All rejected stores in any such event will be at the risk of the firm immediately after such rejection.
  - 14. In case the firm fails to supply the ordered stores, partially or fully, what so ever the reason be, the department shall be at liberty to procure the same at the risk and expenses of the firm. The firm will have to bear all such extra charges and expenses as may be incurred or sustained by the department in procuring and testing the same.
  - 15. The stores supplied shall strictly conform to the labelling provisions laid down under Drug and Cosmetics Rules, 1945 and relevant BIS standards. All labels should be emboldened/imprinted/stamped in bold letters "हरियाणा सरकार आपूर्ति, बिक्री के लिए नहीं" M.R.P. should not be printed.
  - 16. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination. Loose supplies/damaged packing/tempered or damaged labelled supplies shall not be accepted under any circumstances. The firm has to replace the same afresh and the loss incurred due to this, if any, shall be recovered from the firm.
