- 3. CCD or latest advance technology Camera with solid-state long-life laser detector.
- 4. Should have latest version of equipment operation & data collection software. The vendor/supplier shall provide free of cost all subsequent equipment operation & data collection software upgrades for a period of five years from the date of supply. Manufacturers certificate/undertaking shall be attached with the technical specification offer documents.

The supplier should also provide turnkey solution for functionalizing the instrument which shall include but not limited to: suitable anti-vibration workbench, minispin, vortex, set of suitable variable volume pipettes, 96 well plate mini centrifuge, suitable capacity storage equipment for PCR kits and STR consumables having both 4°C and -20°C temperature range facility and suitable room cooling unit for maintaining ambient temperature required for optimum shelf life of chemicals loaded on equipment and its best performance.
- 10. Onsite training to scientists of the end-user user laboratory.
- 11. Complete onsite validation studies with complete IQ, OQ & PQ documentation.
- 12. Compatible online UPS with one hour backup (7 KVA).
- 13. Should be supplied with suitable high quality colored printer.
- 14. Warranty of 5 years from the date of installation and AMC for the subsequent 6 to 8 years with atleast one calibration and preventive maintenance visit every year.
- 15. Instrument Demo must be given if required by the end user technical team.

- 4. <u>DELIVERY PERIOD</u>:- The delivery of the instrument should be completed within 90 days at Karnal or Gurugram..
- 5. Warranty:-05 years.
- 6. <u>PAYMENT TERMS</u> ;- 90% payment will be made within 30 days after a satisfactory inspection and delivery of the equipment 10% after satisfactory installation, commissioning, IQ, OQ & PQ and training.

7. INSPECTION:- The Inspection would be carried out by the Inspection Committee formed by the Indenting Department.

In case, the material offered for inspection by the firm fails to meet the specifications stipulated in NIT/ Order/Contract and the samples are rejected by the inspection committee, the Indenting Department will have the right to levy a penalty at 0.1% of the total order value. In case, the material offered for inspection fails during the 2nd inspection also, the Indenting Department will have the right of increase the penalty to 0.25% of the total order value. In case the material offered fails during the 3rd inspection also, the firm will be liable for penal action including forfeiture of EMD, risk purchase, debarring/ blacklisting in future, and no further opportunity for inspection would be provided to the supplier firm.

8. PRICE FALL CLAUSE:- The price charged for the stores shall not exceed in any way the lowest price at which you quote/supply the stores of identical description of stores to GeM /State Govt./Central Govt./Institutions/ undertaking/any other person during the delivery period/currency period of the rate contracts.
