- 4. The Department will ensure that the total number of positions filled up post shall not exceed the total of 88 sanctioned posts at any point of time.
- 5. Housekeeping (cleaning) Services, Housekeeping (peon) Services and Security Services may be outsourced as per Government Policy in respect of Group-C & D posts.
- 6. The State Govt. has principally approved the draft service rules of Group-A, Group-B and Group-C posts and FD has also concurred. Further action for approval of services rules may be taken by the Department as per instructions in this behalf.
- 7. To initially fill up 50% of Technical Officer posts through outsourcing from Outsourcing Agency at DC rate (1st Phase) and remaining 50% after one year to ensure strengthening in evaluation work of procurement at middle level processing. This arrangement shall be up to such a time till regular candidates join the said posts.
- 8. To initially fill up the one post of System Analyst and one post of Programmer by deployment of similarly placed experts from HARTRON.
- 9. This issues with the concurrence of Finance Department conveyed vide their U.O. No.1/53/2017-4FD III/19/15061 of dated 14/28-08-2019.
