Toyota Innova Hycross, 7- Seaters, Super White Colour, (Petrol), BS-VI. As per decision of meeting of High Powered Purchase Committee (HPPC) held on 07.04.2025 & your e-mail dated 07.04.2025, for the supply of under mentioned vehicle with standard accessories.

Please supply the vehicle within 120 days from the date of issue of supply order to the consignee as given below:-

The vehicle may please be sent direct to the Excise & Taxation Department, Haryana, Panchkula. For payment, the bill of the cost of store in triplicate be sent directly to the Commissioner, Excise & Taxation Department, Haryana, Panchkula under advice to this office.

TERMS & CONDITIONS:-

1. **F.O.R.** :- The above rates are FOR destination basis at supplier's risk.
2. **GST** :- Inclusive in above rates.
3. **Freight Charges** :- Inclusive.
4. **Delivery Period** :- 120 days from the date of issue of supply order.
5. **Payment** :- 100 % payment advance before delivery of Car. Price ruling on the date of invoicing will be applicable; prices may change without prior notice.

6. **Warranty** :- 3 years or 1,00,000 Kilometers whichever is earlier.
7. **Free Service** :- 03 nos.+ 01no. = 4 Nos. (Labour charges free).
8. **Additional Accessories**:- Foot Mats at free of cost.
9. **Inspection** :- Inspection will be carried out at the premises of the dealer by the representative of the Commissioner, Excise & Taxation Department, Haryana, Panchkula or any agency authorized by the Department before taking delivery of vehicles as per specifications.

In case, the vehicles offered for inspection by the firm fails to meet the specifications stipulated in NIT/Order are rejected by the Inspecting Committee, the Indenting Department will have the right to levy a penalty at 0.1% of the total order value. In case, the vehicle offered for inspection fails during the 2nd inspection also, the Indenting Department will have the right to increase the penalty to 0.25% of the total order value. In case, the vehicle offered fails during the 3rd and final inspection also, the firm will be liable for penal action including forfeiture of security, risk purchase, debarring/ blacklisting in future, and no further opportunity for inspection would be provided to the supplier firm.

10. **PENALTY CLAUSE** :- Penalty to firm on Delay in delivery :- Should the contractor fail to deliver or dispatch any consignment within the period prescribed for such delivery or dispatch stipulated in the supply order, the delayed consignment will be subject to 2% penalty per consignment per month recoverable on the value of the stores supplied. The other details will be as per provision contained in Sr. No. 14 of "Schedule-'B' Condition of Contract".
11. **PRICE FALL CLAUSE** :- The price charged for the stores shall not exceed in any way the lowest price at which you quote/supply the stores of identical description of stores to State Govt./ Central Govt./ Institutions/ undertaking/ any other person during the delivery period/currency period of the rate contracts. If at any time during the delivery/currency period, you reduce the rate, sale price of quoted stores to any person at the price lower than the price chargeable under this supply order/contract, you are required to inform this office and price payable under the supply order/contract for the stores supplied after the date of coming into force of such reduction of rates shall stand correspondingly reduced to that level. You shall promptly notify the reduction of rates to this office as well as to concerned Indenting Officers/ Consignees. You shall also give a certificate on your bills that the rates charged by you are not in any way higher to these quoted to other State Govt. Central Govt. Institutions etc. during the corresponding period. The Indenting Officer shall be required to ensure that requisite certificate is given by the concerned firm on the bills before releasing their payments. Full benefit due to reduction in GeM Prices or Net Dealer Price during the period of supply will be passed on to the consignee in addition.
12. Failure to effect supply within stipulated period or repeatedly offering supply liable for rejection may render to penal action as per rules.
