Subject:- Regarding amendment in rates due to reduction in GST against rate contract Nos. 115/HR/RC/E-2/2024-25 6074 dated 01.07.2025 and 115/HR/RC/E-2/6633 dated 10.07.2025 for the supply of ISI Marked 43 grade Ordinary Portland (OP) Cement as per IS:8112 (latest) & Pozzolana Portland(PP) Cement as per ISI no. 1489 (1) latest packed in conventional Jute/HDPE bags of 50 Kg. each.

1. This is in continuation to this office rate contracts issued vide Nos 115/HR/RC/E-2/2024-25/6074 dated 01.07.2025 and 115/HR/RC/E-2/6633 dated 10.07.2025 issued in favour of M/s Shree Cement Ltd., Ajmer and M/s Ultratech Cement Ltd. Gurugram on the subject cited above.

2. The GST council, during its 56th meeting held on 03.09.2025 recommended reduction in GST rate on cement from 28% to 18% effective from 22.09.2025. Hence, the rate mentioned in the issued rate contract by this office for the supply of cement are being revised. The destination wise revised rate shall be as detailed under:-
