### TERMS & CONDITIONS:-

- F.O.R. Destination:-** All the items (ACs and Refrigerators) will be delivered at the concerned ESI dispensary/ hospital/ Civil Surgeons offices. The delivery, installation and commissioning will be F.OR. basis. The delivery and installation must be done by your firm.
- GST :-** Inclusive in above rates.
- Freight Charges :-** Inclusive in above rates.
- Payment Terms:-** The payment will be made by ESI Health Care to the successful bidder after completion of delivery, installation and instrument satisfaction certificate obtained from the ESI institutions. After submission of all documents (copy of original bills with amount verified by the institution incharge, copy of instrument receiving with seal and signed by institution incharge and satisfaction certificate with seal and signed by institution incharge). Payment will be made after completion of above mentioned requirements in all respect and delivery of complete order, 100% payment will be made by ESI Health Care within 45 days after submission. **The Indenting Departments would have option to release payments in RTGS/ Electronics mode also.**

Delay in payments to the suppliers beyond the stipulated credit period indicated in the supply order, unless supported by cogent reasons and approved by a higher

authority, will attract penal interest on the defaulting amount @ Rs.25/- per rupees one lakh per day of delay beyond the stipulated credit period. Non provision of adequate budget will be no ground for delay in payments to the supplier.

5. **Delivery Period:-** The successful bidder has to delivery and install the AC and Refrigerator within 20 days from the date of issuance of supply order.

i. **Warranty/ Guarantee:-**

- Comprehensive Warranty on Air Conditioner/ Machine- 3 years
- Warranty on Compressor - 10 years.
- Number of free service during the Comprehensive Warranty on air Conditioner/ Machine - 2 service per year.

ii. **Penalty clause:-** Delay period/ Deduction (on the value if the goods of delayed supply): the penalty of the unit cost will be applicable in case of delayed supply and installation, as given below:-

- For Delay supply the charges will be as under:-
  - o 1<sup>st</sup> week - 2.5%
  - o 2<sup>nd</sup> week - 5%
  - o 3<sup>rd</sup> week - 5.5%
  - o 4<sup>th</sup> week - 10%

Once the maximum is reached, ESI Health Care may consider termination of the contract.

For Delay installation/ commissioning the charges will be as under:

- o 1<sup>st</sup> week - 2.5%
- o 2<sup>nd</sup> week - 5%
- o 3<sup>rd</sup> week - 5.5%
- o 4<sup>th</sup> week - 10%

6. **Inspection:-** The inspection will be carried out by the representatives of the Indenting Department.

In case, the material offered for inspection by the firm fails to meet the specifications stipulated in NIT/Order/Contract and the samples are rejected by the inspecting Committee, the indenting Department will have the right to levy a penalty at 0.1% of the total order value. In case, the material offered for inspection fails during the 2nd inspection also, the Indenting Department will have the right to increase the penalty to 0.25% of the total order value. In case, the material offered fails during the 3rd and final inspection also, the firm will be liable for penal action including forfeiture of EMD, risk purchase, debarring/ blacklisting in future, and no further opportunity for inspection would be provided to the supplier firm.

7. **PRICE FALL CLAUSE :-** The price charged for the stores shall not exceed in any way the lowest price at which you quote/supply the stores of identical description of stores to State Govt./Central Govt./Institutions/ undertaking/ GeM any other person during the delivery period/ currency period of the rate contracts. If at any time during the delivery/currency period, you reduce the rate, sale price of quoted stores to any person at the price lower than the price chargeable under this supply order/contract, you are required to inform this office and price payable under the supply order/contract for the stores supplied after the date of coming into force of such reduction of rates shall stand correspondingly reduced to that level. You shall promptly notify the reduction of rates to this office as well as to concerned Indenting Officers/ Consignees. You



shall also give a certificate on your bills that the rates charged by you are not in any way higher to these quoted to the GeM, New Delhi and other State Govt. Central Govt. Institutions etc. during the corresponding period. The Indenting Officer shall be required to ensure that requisite certificate is given by the concerned firm on the bills before releasing their payments. Full benefit due to reduction in GeM rate contract or Net Dealer Price during the period of rate contract/ supply will be passed on to the consignee in addition.

8. Failure the effect supply within the stipulated delivery period or repeatedly offering supply liable for rejection may render to forfeiture of Earnest Money/ Security and other penal action as per terms & conditions of the contract will also be taken.
