It is brought to your kind notice that M/s SCM Xpress Pvt. Ltd., is a Joint Venture which was engaged by Haryana State Warehousing Corporation (HSWC) for operation and management of ICD-cum-CFS, Rewari under a Strategic Alliance Management Operator (SAMO) arrangement, has failed to discharge its contractual obligations in accordance with the terms and conditions of the Agreement executed with HSWC.
