E-Cart as per GSR 709 E.	"E-cart" means a special purpose battery operated vehicle having three wheels and intended to provide last mile connectivity for carrying goods for hire or reward, provided, such vehicle is constructed or adopted for

The floor base of the E-Cart loader shall be made of MS sheet of minimum 1.6 mm thickness and side walls shall be made of minimum 0.8mm thickness, with suitable stiffeners which is duly surface treated with stoving PU paint/ gloss surface finish so as to avoid rusting. The E Cart will have two sections i.e. cabin for seating of driver and loader part for transporting feed & fodder etc. for Gaushalas. The dimensions of close body loader section having roof with provision of opening from Back and both sides (left & right) will be 1.22 m x 1.0 m x 1.14 m and as per indicative drawing annexed as Annexure-iv of DNIT. The Left, Right and Rear sides walls of loader will be covered at upper and lower sides (380 mm each height) with MS sheet of minimum thickness of 0.8 mm. The middle portion of Left, Right and Rear sides of walls of loader will be opened. The uppermost portion of back side of loader shall have two doors with provision of opening from the centre and these doors shall have a locking system also. All the lower sides of loader shall have the provision of opening by lowering down the respective sides. All the doors shall have a good locking system to

	prevent the sudden/unwilling opening of doors. Four removable plastic food carrying boxes each having minimum 400mm x 300mm x 250mm size and having minimum thickness of 6 mm will be provided in loader section. These boxes will be provided along with plastic lids/covers of suitable thickness.

❖ **TERMS AND CONDITIONS:-**

1. **F.O.R. :** - The rates should be F.O.R. destination anywhere in Haryana at supplier's risk.
2. **GST:** Inclusive
3. **FREIGHT CHARGES:** Inclusive
4. **DELIVERY PERIOD:** - 02 Months from the date of placement of supply order.
5. **PAYMENT:** Payment will be made within 30 days after receipt of physical delivery of inspected / accepted vehicles at consignee destination. The Indenting Department would have option to release payments in RTGS/Electronics mode also.

Delay in payments to the suppliers beyond the stipulated credit period inducted in the supply order, unless supported by cogent reasons and approved by a higher authority, will attract penal interest on the defaulting amount @ Rs.25/- per rupees one lakh per day of delay beyond the stipulated credit period. Non provision of adequate budget will be no ground for delay in payments to the supplier.

6. **INSPECTION:** The inspection will be done by the indenting department or his authorized representatives at the firm's premises before dispatch of material.
Pre-dispatch Inspection: - The supplier will offer the material for pre-dispatch inspection before supplying the material at least 15 days before the completion of delivery period. In case, the material is found defective/substandard, the whole lot of supply will be rejected and the firm will be liable to replace the entire quantity or

make full payment of the entire rejected stores irrespective of the fact that a part or whole of the supplied stores may have been consumed. All rejected stores in any such event will be at the risk of the firm immediately after such rejection.

In case, the material offered for inspection by the firm fails to meet the specifications stipulated in NIT/ Order/contract and the samples are rejected by the inspection committee, the Indenting Department will have the right to levy a penalty at 0.1% of the total order value. In case, the material offered for inspection fails during the 2nd inspection also, the Indenting Department will have the right of increase the penalty to 0.25% of the total order value. In case the material offered fails during the 3rd inspection also, the firm will be liable for penal action including forfeiture of EMD, risk purchase, debarring/ blacklisting in future, and no further opportunity for inspection would be provide to the supplier firm.

7. **VEHICLE GUARANTEE / WARRANTY:** Minimum 3 years of Guarantee / Warranty of E-Rickshaw from the date of delivery on site as specified in FOR (Mainly includes motor, controller, charger, chassis paint, coating etc.).

Note:

- (i) The supplier will supply the E-cart from the stock Manufactured after 1st April 2025 or from the stock manufactured in the calendar year of placement of purchase order whichever is later.
- (ii) During the Warranty /Guarantee, the supplied material may be subjected to further testing at any point of time at the cost of the vendor.

8. **BATTERY GUARANTEE / WARRANTY:** Guarantee / Warranty of battery and battery charger is for 3 Years from the date of delivery.

9. **NUMBER OF FREE SERVICES OF COMPLETE VEHICLE:** Three Services.

10. **PENALTY CLAUSE :-** Penalty to firm on Delay in delivery: If the contractor fail to deliver or dispatch any consignment within the period prescribed for such delivery or dispatch stipulated in the supply order, the delayed consignment will be subject to 2% penalty per consignment per month recoverable on the value of the stores supplied. The other details will be as per provision contained in Sr. No. 14 of "Schedule- 'B' Condition of Contract".

11. **PRICE FALL CLAUSE:**

The price charged for the stores shall not exceed in any way the lowest price at which you quote/supply the stores of identical description of stores to State Govt./Central Govt./Institutions/ undertaking/ GeM any other person during the delivery period/ currency period of the rate contracts. If at any time during the delivery/currency period, you reduce the rate, sale price of quoted stores to any person at the price lower than the price chargeable under this supply order/contract, you are required to inform this office and price payable under the supply order/contract for the stores supplied after the date of coming into force of such reduction of rates shall stand

correspondingly reduced to that level. You shall promptly notify the reduction of rates to this office as well as to concerned Indenting Officers/ Consignees. You shall also give a certificate on your bills that the rates charged by you are not in any way higher to these quoted to the GeM, New Delhi and other State Govt. Central Govt. Institutions etc. during the corresponding period. The Indenting Officer shall be required to ensure that requisite certificate is given by the concerned firm on the bills before releasing their payments. Full benefit due to reduction in GeM rate contract or Net Dealer Price during the period of rate contract/ supply will be passed on to the consignee in addition.

12. One copy of schedule "B" i.e. conditions of contract applicable is sent herewith duly signed & stamped on behalf of Governor of Haryana.
13. Failure to effect supply within stipulated period or repeatedly offering supply liable for rejection may render to penal action as per rules.

In case of non supply or any breach of this contract, penal action would be taken.

Other terms & conditions will be as per NIT /Schedule-A & Schedule-B attached.

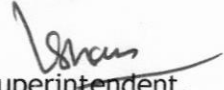

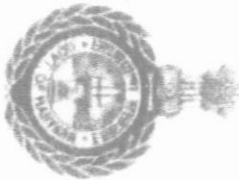

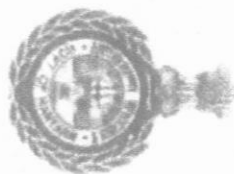
