ORDER

1. The present first appeal has been filed by the appellant under Section 19(1) of the Right to Information Act, 2005 (hereinafter referred to as "the Act"), against non-furnishing of information sought by him vide RTI application received through email dated 07.04.2026. The appeal dated 13.05.2026 was received in the office of the First Appellate Authority (FAA) on 18.05.2026.
2. The Appellant was afforded an opportunity of first personal hearing on 07.07.2026, however, vide email dated 04.07.2026 the appellant informed that he apprehended a threat from certain persons against whom information had been sought as they are highly influential person and the appellant denied to appeared in person before the competent authority due to reason above mentioned.
3. Thereafter, the undersigned had provided opportunity of hearing through Video Conference in which 1st hearing was to be scheduled on 21.07.2026 and second hearing was to be scheduled on 07.08.2026. Applicant was asked to deposit Identity proof as per provision of RTI Act-2005. The Appellant had not appeared on above mentioned dates and requested vide email dated 20.08.2026 to decide the appeal on merits on the basis of records available before the Appellate authority as per the provision of the RTI Act. The applicant has been submitted his Aadhar Card as Identity Proof for further process of his appeal.
4. In view of aforesaid email dated 20.08.2026 of the appellant, First Appellate Authority (FAA) directed the SPIO and concerned branch assistant O/o Director General, Supplies



and Disposals, Haryana to appear in person on 31.08.2026 at 11:00 AM along with complete and relevant record of the case.

5. The SPIO, O/o Director General, Supplies and Disposals, Haryana, appeared in person before the FAA and submitted that earlier, the requisite information could not be provided to the applicant as the matter was under consideration. The same was duly conveyed to the applicant. In the meantime, the applicant continued to send his RTI application to various e-mail addresses of the State Government and also filed the First Appeal. The SPIO further submitted that, when the information pertaining to one case became available, the applicant was intimated about the additional amount payable towards the cost of photocopying the information on a per-page basis. However, till date, the applicant has neither furnished any response nor deposited the requisite amount. At present, the SPIO submitted that the requisite information, as sought by the applicant, can now be provided, as the necessary proceedings in the matter have since been completed.
6. In view of the above, the information sought by the appellant, insofar as it is available on the record and the aforesaid information sought by applicant is disclosable under the RTI Act and same may be furnished to the appellant. Accordingly, the SPIO is hereby directed to furnish the requisite information, in clear, legible and certified form, to the appellant forthwith, subject to the provisions of the Act.
7. The appeal is accordingly disposed of with the above directions. A copy of this order be supplied to the appellant and the SPIO for compliance.
8. If the appellant is not satisfied with this order/ information sought by him, he/she may file an appeal before State Information Commission Haryana, SCO-70-71 (1st Floor), Sector-8, Chandigarh.
