Listing of agenda for High Powered Purchase Committee meetings (HPPC) and High Powered Works Purchase Committee meetings (HPWPC).

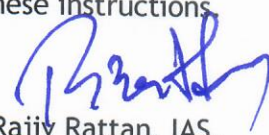
