What are Public Utility Services?

1. Transport Service for the Carriage of Passengers or Goods by Air, Road or Water; or
2. Postal, Telegraph or Telephone Service; or
3. Supply of Power, Light or Water to the Public by any Establishment; or
4. System of Public Conservancy or Sanitation; or
5. Service in Hospital or Dispensary; or
6. Insurance Service; or
7. Education or Educational Institutions; or
8. Housing and Real Estate Service; or
9. Banking & Financial Services; or
10. Old Age Pension; or
11. Pension to Widows and Destitute Women; or
12. Financial assistance to dependent children of Widows and Destitute Women; or
13. Pension to disabled persons; or
14. Financial Assistance for the marriage of daughters of Widows/Destitute Women belonging to S.C. Community; or
15. Post delivery financial assistance to women for nutrition; or
16. Encouragement to inter caste marriage; or
17. Subsidy on petrol/diesel to Persons with Disabilities; or
18. Unemployment Allowance to Persons with Disabilities; or
19. Assistance to Persons with Disabilities for purchase of aids/appliances; or
20. Apni Beti Apna Dhan Scheme; or
21. Hamari Beti Scheme;

How to file case before Permanent Lok Adalat (Public Utility Services)

Cases relating to Public Utility Services can be filed through an application on plain paper before the Chairman, Permanent Lok Adalat (Public Utility Services) at District Court Complex, ADR Centre, Sector 43, Chandigarh. The pecuniary Jurisdiction of the Permanent Lok Adalat is Rs. One Crore.

Benefits of filing case before Permanent Lok Adalat (PUS)

1. Speedy disposal of cases/disputes;
2. No court fee is required to be paid;
3. Award of PLA (PUS) is deemed to be a decree of Civil Court;
4. No Appeal can be filed against the Award of PLA (PUS);
5. PLA (PUS) can execute its own orders;
