
1. Smt. Neelam Nauharia, Senior Architect - Chairperson/Presiding Officer

In terms of provisions of the aforesaid act, the Internal Complaint Committee shall be deemed to be an inquiry authority for the purpose of "Haryana Civil Services (Punishment and Appeal) Rules, 2016" and the report of said Committee shall be deemed to be an inquiry report. Disciplinary authority shall act upon the report in accordance with the rules.

The Internal Complaints Committee shall be responsible for redressal of the complaint made by the victim and ensure time bound treatment of the complaint as provided in the act.

The Presiding Officer and every member of the "Internal Complaint Committee" shall hold office for such period not exceeding three years, from the date of her nomination..


