# **RELAXATION IN AGE:-**

Relaxation in age under various circumstances to entry into government service will be governed as per Haryana government letter No. 22/06/2021-1GS-III dated 03.02.2021.

- i) The minimum age of a person for entry into Government service shall be 18 years and maximum age shall be 42 years in respect of the posts of all Groups A, B, C & D in addition to the age relaxation prescribed herein for various categories.
- ii) Age relaxation for various categories is as under:-

(viii)	Disabled persons who covered under the Rights of Persons with Disabilities Act, 2016.	(i) 10 years (+5 years if candidates belongs to S/Caste, S/Tribe, B/Classes) subject to maximum 55 years, for all posts of Group C & D, and also for Group A & B posts where recruitment is made otherwise than through open competitive examination. (ii) 5 years (+5 years if candidates belongs to S/Caste, S/Tribe, B/Classes) subject to maximum 55 years for Group A & B posts where recruitment is made through open competitive examination. Note: - Relaxation in age limit shall be applicable irrespective of the fact whether the post is reserved or not,			

		provided the post is identified suitable for persons with disabilities.

\*For Ex-serviceman: For appointment of an ex-serviceman to a post of Group A, B, C or D, his/her age will be calculated keeping in view the actual age minus (actual period of military service plus three years). If the resultant age does not exceed the maximum age limit prescribed for the post for which he/she is seeking appointment he/she shall be deemed to satisfy the condition regarding age limit.

#### Criteria for Selection, Examination & Syllabus.

The criteria for the selection, Examination and syllabus will be Haryana Government Notification No. G.S.R. 25/Const./Art. 309/2019 dated 11.06.2019

a) The scheme of marks in respect of selection to the posts shall comprise of total 100 marks, as detailed below:-

- b) The 90 marks of written examination shall be divided into two parts comprising:
  - a. 75% weightage for syllabus of Diploma in Architectural Assistantship.
  - b. 25% weightage for History, Current Affairs, Literature, Geography, Civics, Environment, Culture etc. of Haryana.
- c) The 10 Marks for socio-economic criteria and experience shall be allocated as follows:
  - a. If neither the applicant nor any person from among the applicant's family viz father, mother, spouse, brother and Son is, was or has been a regular employee in any Department/Board/Corporation/Company/Statutory Body/Commission/Authority of Government of Haryana or any other State Government or Government of India.

(5 marks)

- b. If the applicant is:
  - i. A window; or
  - ii. The first or the second child and his father had died before attaining the age of 42 years; or
  - iii. The first or the second child and his father had died before the applicant had attained the age of 15 years.

(5 marks)

c. If the applicant belongs to such a denotified tribe (Vimukt Jatis and Tapriwas Jatis) or Nomadic tribe of the State of Haryana which is neither a Scheduled Caste nor a Backward Class.

(5 marks)

### d. Experience:

One-half (=0.5) mark for each year or part thereof exceeding six month of experience, out of a maximum of sixteen years, on the same or a higher post in any Department/Board/Corporation/Company/Statutory Body/Commission/Authority of Government of Haryana. No marks shall be awarded for any period less than six months.

(A maximum of 8 marks)

**Note:-** No applicant shall be given more than 10 marks for socio economic criteria and experience under any circumstances.

#### Benefit of reservation to Ex-servicemen

The benefit of reservation to Ex-servicemen and their children will be Haryana Government letter No. 12/15/2019-4GS-II dated 14.07.2021

- An ex-serviceman who himself/herself has already secured employment in civil service on regular basis in any Department/ Board/ Corporation/
  University etc. under the State Government with or without availing the benefit of reservation
  - a. He/she himself/herself shall not be eligible to avail the benefit of reservation in civil service for any subsequent appointment in any Department/ Board/ Corporation/ University etc. under the State Government. However, the benefit of age relaxation for securing another employment in a higher pay scale or post shall remain continue; and
  - b. His/her children will also not be eligible to avail the benefit of reservation against the posts reserved for ex-servicemen.
- B. Where an ex-serviceman who himself/herself is eligible to avail the benefit of reservation but he/she does not want re-employment in civil service in such case one of his/her children will be entitled to avail the benefit of reservation.
- C. No children of martyr military personnel shall be entitled to avail the benefit of reservation because one family member is entitled to avail the benefit of compassionate appointment under the Policy of Compassionate Appointment to family member of Martyr Armed Forces Personnel.
- D. The priority list for recruiting agency for appointment of ex-servicemen or their children against the posts reserved for ex-servicemen shall be as under:-
  - (i) Disabled ex-servicemen, the post(s) for which they are physically fit;
  - (ii) failing (i), children of disabled ex-servicemen;
  - (iii) failing (ii), other ex-servicemen who are eligible for re-employment in civil service;
  - (iv) failing (iii), children of other ex-servicemen who are eligible for reemployment of civil service.
- E. Disabled ex-serviceman means a person who has been released from military service due to disability attributable or aggravated due to military service. An ex-serviceman shall not be treated disabled one who has been released from military service not on account of his/her disability but has been released in the normal course after the completion of his/her term or retired from military service voluntarily.
- F. An ex-serviceman who have been discharged from military service by way of dismissal, misconduct or inefficiency neither he/she himself/herself nor his/her children shall be entitled to avail the benefit of reservation in civil service.
