

Water Heroes: Share Your Stories Contest 3.0

Terms and Conditions

- The submission of entry is free and no qualifications are prescribed. All Indian citizens in their personal capacity or on behalf of their NGO/Organization with proper authority letter from organization are entitled to participate in the contest.
- The participant shall post their Success Stories on MyGov (www.mygov.in) Portal page. The Success Stories in the field of water conservation and management will comprise of a (i) Write-up in English or Hindi (upto 300 words), (ii) Pictures/Photos and (iii) Video clips of one to five minutes' duration depicting the efforts/ significant contributions/ best practices used in different parts of the country in the field of water conservation, water utilization or water resources development and management.
- The participant shall share their stories, pictures/photos along with the link of their Youtube video by using their registered id on the MyGov Portal. In addition to MyGov portal, the entries may also be submitted to <u>waterheroes.cgwb@gmail.com</u>. Entries submitted through any other medium/mode would not be considered for evaluation.
- All selected entries shall be awarded a cash prize of Rs. 10,000/- each. A maximum of 10 winners per month shall be awarded cash prize and certificate.
- The entry must not contain any provocative, objectionable or inappropriate content.
- One entrant can participate only once. Multiple entries from the same entrant shall not be considered and will be discarded.
- The entry must be original and should not violate any provision of the Indian Copyright Act, 1957 or the Intellectual Property Rights of any third party.
- All entries received by the stipulated date, and found in order, shall be evaluated by a Committee constituted by the Ministry. The decision of the Committee will be final.
- The winning entries would be the intellectual property of the Ministry of Jal Shakti and the winner shall not exercise any right over it. The Ministry will have unfettered right to modify the prize winning entry and may use them for promotional purposes, Information,

Education and Communication (IEC) materials and also for any other use as may be deemed appropriate.

- Each of the winners will be notified through email address that they will provide along with their submission. The MyGov portal shall also display the names of winners. The prize money shall be transferred through RTGS/NEFT.
- The Government of India, if it so decides, reserves the right not to proceed with the competition at any stage. The Ministry reserves the right to cancel or amend all or any part of this Contest and/ or Terms and Conditions/ Technical Parameters/ Evaluation Criteria.
- Taxes are the sole responsibility of the teams receiving prizes. Prizes may be subject to tax reporting and other purposes. Participants agree to supply with any necessary information to affect the same and to fully cooperate in fulfilling all applicable legal requirements.
- The participant should make sure that his/her MyGov profile is accurate and updated since the Ministry would be using this for further communication. This includes details such as name, photo, complete postal address, email ID and phone number. Entries with incomplete profiles would not be considered.
- All Government employees participating in this competition should have prior permission from their employer to participate in this competition.
- The responsibility to comply with the guidelines and other terms and conditions fully lies with the participant (s) and the Government of India shall not be answerable to any dispute raised by a third party.
- The decision of the Ministry, in this regard, shall be final and shall not be called upon to question under any circumstances. Any legal proceedings arising out of the competition/ its entries/ winners shall be subject to local jurisdiction of NCT of Delhi only.
