### Sear Sin,

The important issues / developments related to the Department of Water Resources, River Development & Ganga Rejuvenation during the month of January are as follows:-

- Storage Position of Important Reservoirs: Central Water Commission is monitoring live storage position of 150 important reservoirs spread all over the country and issuing bulletin on every Thursday. Overall storage position in 150 reservoirs as on <u>25.01.2024</u> was **95.326 BCM** which is **82%** of the live storage of corresponding period of last year and **95%** of storage of average of last ten years. From the 150 Reservoirs, **20** reservoirs are of hydro-electric projects having total live storage capacity of **35.299 BCM**, out of which **11** Reservoirs have Storage less than or equal to average of previous 10 years.
- Inauguration of Projects: On January 25, 2024, the Hon'ble Prime Minister inaugurated the following projects with a cumulative cost of ₹ 790.5 Crores.
  - i. (a) Construction of 30 MLD STP at Masani, Mathura (under Hybrid
    - Annuity-based PPP (HAM) model under Namami Gange Program).
    - (**b**) Rehabilitation of existing (30 MLD at Trans Yamuna and 6.8 MLD STP at Masani, Mathura) total 36.8 MLD.
    - (c) Construction of 20 MLD TTRO plant (Tertiary Treatment and Reverse Osmosis Plant), Masani, Mathura.
  - ii. Construction of 58 MLD STP with 264 km and sewerage Network at Moradabad.
- 'All India Secretaries' Conference on Water Vision @ 2047- Way Ahead:

Ministry of Jal Shakti organized two-day 'All India Secretaries' Conference on Water Vision @ 2047 - Way Ahead' at Mahabalipuram, Chennai, Tamil Nadu on 23<sup>rd</sup> and 24<sup>th</sup> January, 2024 with the key objective to strengthen the water security of the country. 32-States and Union Territories, 30-Secretaries and more than 300 delegates participated in this conference, sharing their best practices and action taken on the 22 recommendations of "1<sup>st</sup>All India Annual State Ministers' Conference on Water" held on 5<sup>th</sup> and 6<sup>th</sup> January, 2023 at Bhopal, Madhya Pradesh and to highlight best practices in various water related issues. In order to document the journey of the Jal Shakti Abhiyan and best practices of water conservation in various parts of the country, NWM compiled the best practices under 'Jal Shakti Abhiyan: Catch the Rain' in the form of an e-Book. This e-Book was launched during the event.

A special attraction of the Conference was 'Publication Curation' where over 150 important publications from Centre/ States/ Civil Society Organizations etc. were displayed. A Round Table Conference of Secretaries and CEOs was also held during the Conference to discuss important issues pertaining to water sector wherein 12 CEOs participated. 33 presentations were made and 7 movies were showcased during five thematic sessions of the Conference which include (i) Climate Resilience and River Health; (ii) Water Governance; (iii) Water Use Efficiency; (iv) Water Storage and Management; and (v) People's Participation/Jan Baghidari. The Conference ended with a presentation of important takeaways emerged during the deliberations held in 2 days' Conference on which feedback of the stakeholders were invited.

### Atal Bhujal Yojana

Secretary (WR) took a meeting to review the progress of Atal Bhujal Yojna by visiting the Pipariya Village of Salaiya Gram Panchayat of Raj Nagar Block, District Chhattarpur, MP along with Joint Secretary (A, IC & GW) Govt. of India, Principal Secretary, Govt. of MP, were present along with Collector Chhattarpur and Project Director, SPMU, Atal Bhujal Yojana, MP. Secretary (WR) interacted with the villagers regarding ground water awareness under Atal Jal Yojna. Also, villagers shared their experiences on ground water management and initiatives taken for adaptation of water saving methods and new initiatives practices.

Secretary (DOWR, RD&GR) also visited Panna Tiger Reserve with the Field Director, Panna Tiger Reserve to discuss implementation of Integrated Landscape Management Plan with the coordination of all the stakeholders.

- 6. Officers of CWPRS, Pune started vertical shear wave velocity based seismic studies and geophysical investigations pertaining to Damanganga Vaitarna Godavari link project on 30.01.2024.

The aim of this conference was to enhance existing treatment installations and implement decentralized sewage treatment for urban and peri-urban settings, with water reuse and resource recovery within the framework of the Circular Economy.
