Mahadayi Water Disputes Tribunal, Ministry of Jal Shakti, Department of Water Resources, RD & GR invites applications from the eligible candidates (serving government employees for selection on deputation basis, retired government employees for selection on re-employment basis and others for selection on direct recruitment basis) for filling up the following post:

The method of recruitment for the post of Assistant is through deputation (including short term contract) failing which through re-employment failing which direct recruitment on contract basis. For recruitments on deputation basis, period of deputation/contract including the period of deputation/ contract in another excadre post held immediately preceding this appointment in the same or some other Organization/ Department of the Central Government shall ordinarily not exceed 3 years or till the life of the Tribunal or till further orders whichever is earliest. The maximum age limit for appointment by deputation including short term contract shall not be exceeding 56 years. For recruitments on re-employment basis, the initial appointment shall be for one year, likely to be extendable on year to year basis subject to the condition that the retired Govt. Servant appointed to the post shall cease to hold the post of Assistant after he attains the age of 65 years. For recruitments on direct recruitment on contract basis, the age of the applicant should be upto 45 years as on date of advertisement. A person who is selected for
