Applications are invited from eligible candidates for filing-up of one post of Assessor (Group A), which are likely to be vacant soon, to be filled up on deputation/ re-employment basis in Mahanadi Water Disputes Tribunal from the employees/officers from Central Govt ./ U.T. / State Governments/P.S.U, on terms and conditions of deputation, as contained in DoPT OM No.2/29/91-Estt. (Pay II), dated 17<sup>th</sup> June, 2010(as amended from time to time) and in respect of re-employment, employees/officers retired from Central Govt./U.T./State Governments/P.S.U on terms and conditions of re-employment issued vide DoPT O.M. No. 3/03/2016-Estt.(Pay II) dated 01.05.2017 ( as amended from time to time):

### 1.Assessor:- On deputation(including short term contract)-

- (i) Holding analogous post on regular basis; **OR** holding a post in Level 14 of the 7<sup>th</sup> CPC Pay matrix (or equivalent) with three years regular service in the grade; **OR** officers with 25 years of regular service in Group A posts, out of which at least one year regular service should be in the SAG(Level-14). **AND**
- (ii) having BE(Civil Engineering) from recognized University or equivalent; AND
- (iii) having at least 15 years' experience in irrigation projects/water management/Inter-State Water Disputes.

Note: period of deputation/contract including the period of deputation/contract in another excadre post held immediately preceding the appointment in the same or some other Organization/department of the Central Government shall ordinarily not exceed 3 years or till the life of the Tribunal or till further orders whichever is the earliest. The maximum age limit for appointment by deputation shall not exceed 56 years.

Re-employment:- Officer retired from the Central Government/State Government/UT/PSUs/Autonomous/Semi-Government/Statutory Organisation etc having held (i) analogous post on regular basis **OR** holding a post in Level-14 of the 7<sup>th</sup> CPC Pay matrix (or equivalent) with three years regular service in the grade **OR** officer with 25 years regular service in the Group A posts in the service out of which at least one year regular service should be in the SAG **AND** possessing qualification and experience as of (ii) & (iii) above provided that the retired Government servant appointed as Assessor shall cease to hold the post of Assessor after he attains the age of 67 years.



- \*\* Person applying for the post should have knowledge in working on computer (word, excel, power point etc.) and also knowledge in Legal affair (desirable).
- 2. The applicants should clearly indicate (as per the form given in the Annexure) in their bio-data, i.e name, father's name, date of birth, date of superannuation( in case of VRS attach last office certificate), present designation with pay-scale, post held on regular basis with date and pay-scale, name of the superannuation department with address, number, service / experience in chronological order, educational / technical/special qualification, training if any undergone and any other information relevant to the post, with the declaration of completeness and correctness of application and declaration that he will not be allowed to withdraw his candidature once selected for the post.
- 3. The person selected for appointment will not be eligible for Govt. accommodation during the period of deputation /re-employment in this Tribunal.
- 4. The respective Office/Department while forwarding the applications of the candidate(s) for deputation should clearly certify the particulars along with CR dossiers for the last 5 years and enclose the list of major/minor penalties imposed (if any) together with Vigilance/Disciplinary clearance.
- 5. Application should reach "The Registrar, Mahanadi Water Disputes Tribunal" at above mentioned address, within 45 days from the date of publication of this advertisement in the Employment News.
