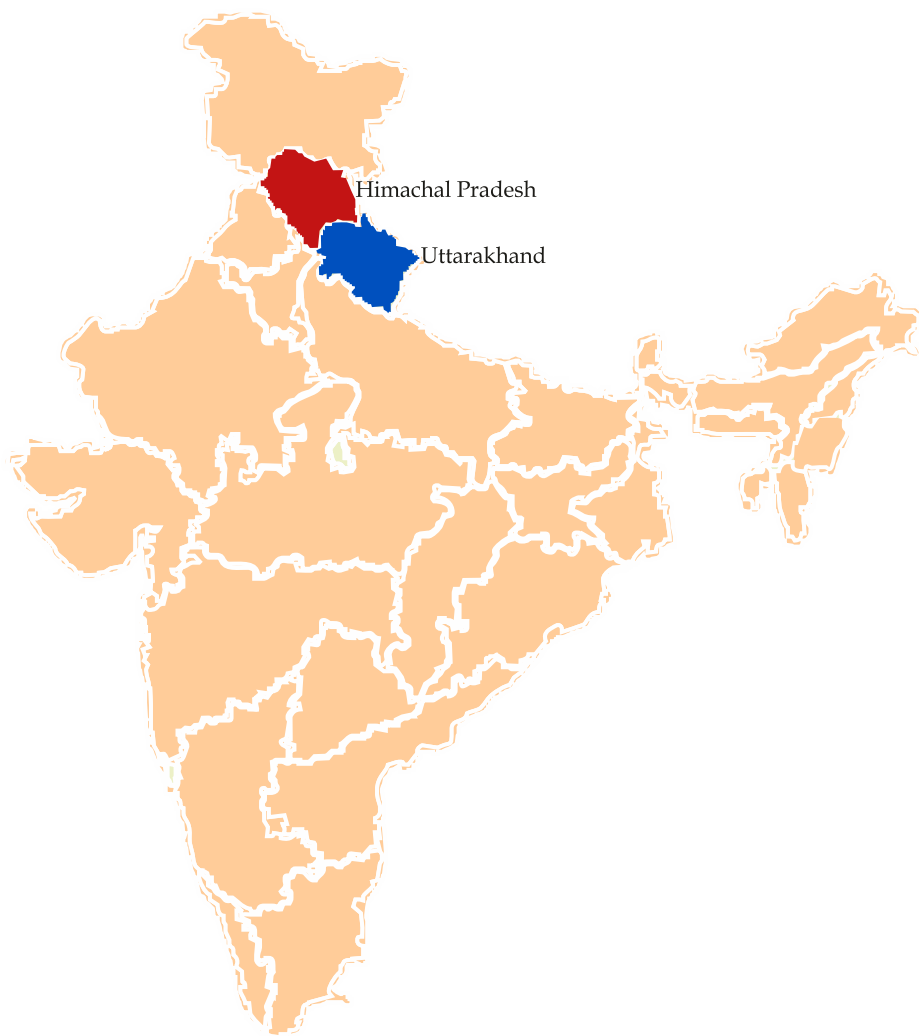

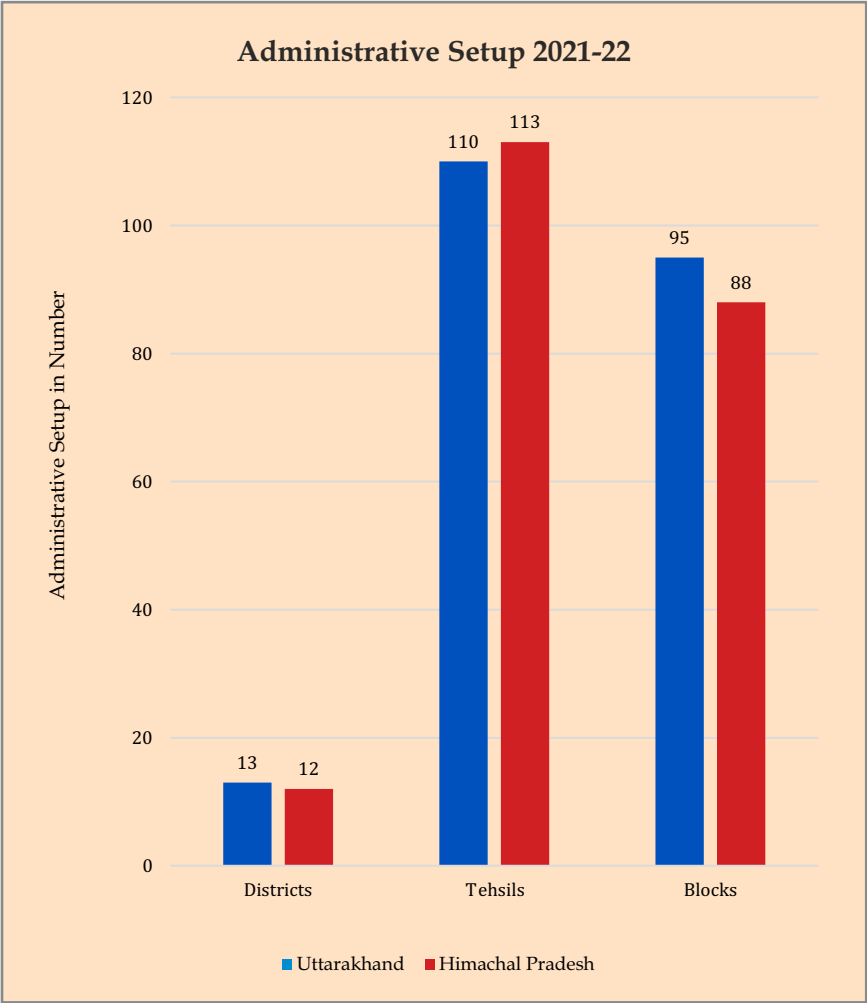

I : INTRODUCTION AND AREA & POPULATION

1.1 - Introduction

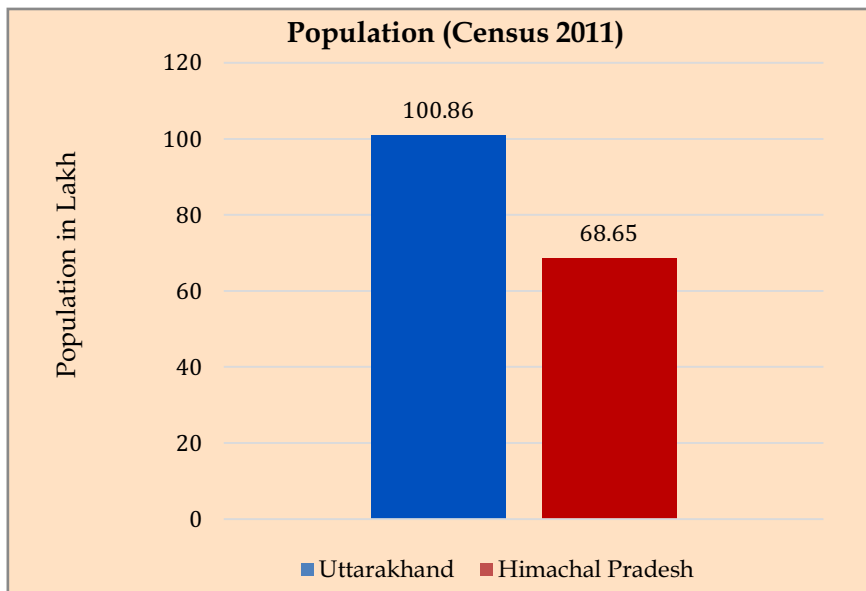
The Himalayan belt in India stretches for about 2500 kms thereby covering a total of 13 State & Union Territories having combined population of more than 50 Million. This stretch can be characterized as having diverse, demography, topography and peculiar socio-economic environment. While most of these States/UTs are unique in their ways, some of these share more aspects in common than other. Notable among such similar ones are Himachal Pradesh and Uttarakhand, the neighboring States in the northern part of the country. Both the States have predominantly large hill areas under forests. These States have many common characteristics, such as topography, geographical area, climate, forest cover demography and socio-economic development pattern.

Before analyzing their socio-economic development, it is necessary to go through the historical background of the two states. Himachal Pradesh came into existence in 1948 as a centrally administered territory ie UT. Though it became full state in the year 1971, it has participated in all the Five Year Plans. On the contrary, Uttarakhand was carved out of Uttar Pradesh and came into existence as a separate state on 9 November, 2000. Though Sixth Five Year Plans onwards, a separate Hill Sub Plan was formulated for the hill districts, the availability & utilization of plan funds was relatively lower. This has caused a massive gap between their developmental and growth patterns.

Thus, through this publication an attempt has been made to analyze the socio economic pattern and the development scenario of Uttarakhand and Himachal Pradesh. For analytical studies, indicator-wise analysis has been opted within different sectors. Statistical Diary 2021-22, Uttarakhand and Statistical Abstract of Himachal Pradesh 2021-22 & Statistical Year Book of Himachal Pradesh 2021-22 are the main sources of data that have been used for the comparative study.

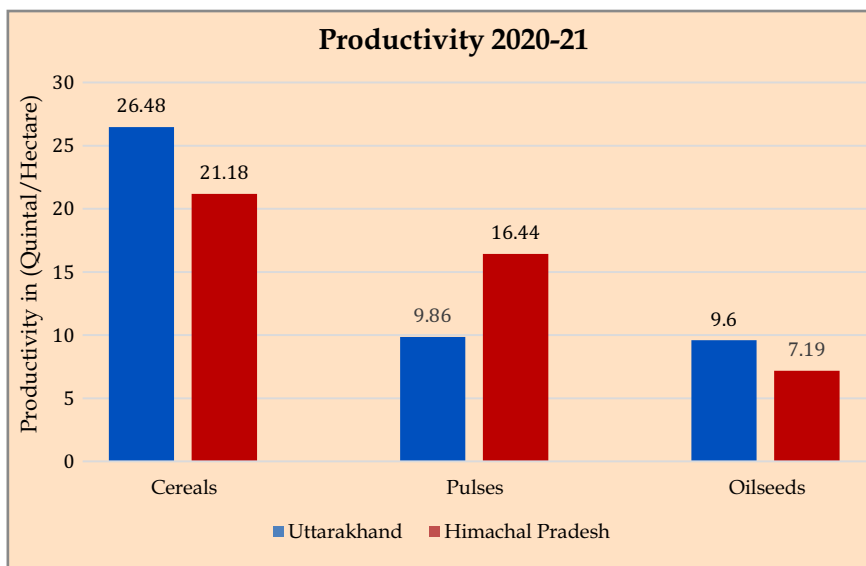
Both the States are geographically and administratively similar. Where as Himachal Pradesh consists of 12 Districts, 113 Tehsils and 88 Development Blocks, Uttarakhand has 13 Districts, 110 Tehsils and 95

Development Blocks. This publication mostly concentrates on following sectorwise comparisons:-

1. Area & Population
2. Agriculture & Allied Activities
3. Infrastructure Development Road, Electricity, Irrigation & Banking (Including Tourism)
4. Social Sector- Education & Health
5. State Finance and Economic Growth

1.2 Area & Population

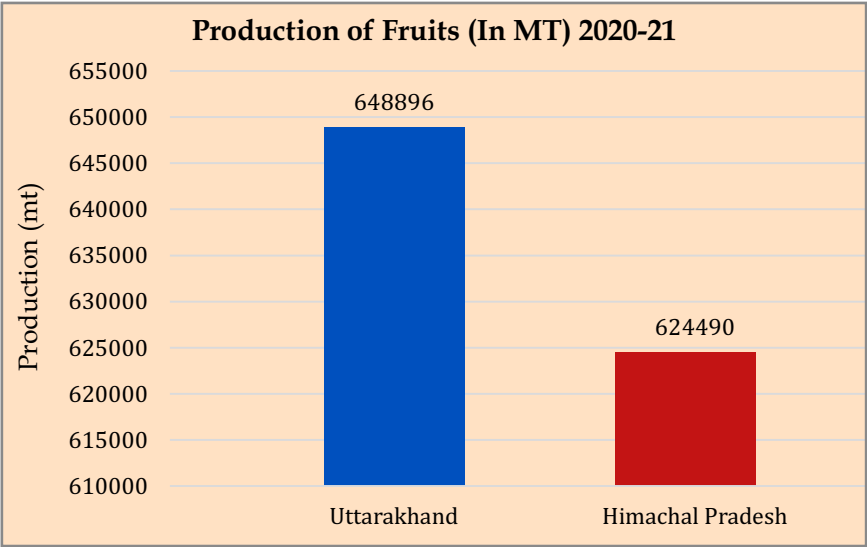
As per Census 2011 total population of Uttarakhand is 100.86 Lakh and that of Himachal Pradesh is 68.65 Lakh. Density of population in Uttarakhand is 189 persons per sq km while it is 123 persons per sq. km. in Himachal Pradesh. Both states have almost same/ similar by geographical area. Total geographical area of Uttarakhand is 53483 sq. km where as its 55673 sq. km. in Himachal Pradesh.

II: AGRICULTURE AND ALLIED ACTIVITIES

2.1 Agriculture: First and foremost, the land use pattern between the two states is analyzed. For the year 2019-20, Percentage of Net Area Sown to Total Reported Area of Uttarakhand is 10.63 as compared to 11.59 of Himachal Pradesh. The difference is marginal but the percentage of Net Irrigated Area to Net Area Sown of Uttarakhand is higher as (49.73) compared to Himachal Pradesh (22.01). It indicates a vast difference in number as compared to Himachal Pradesh.

As far as productivity of different crops is concerned, productivity of pulses 9.86 Qtl./Ha. for 2020-21 in Uttarakhand is much lower as compared to Himachal Pradesh's provisional data of 16.44 Qtl./Ha. Productivity of cereals 26.48 Qtl./Ha. for 2020-21 in Uttarakhand is higher than Himachal

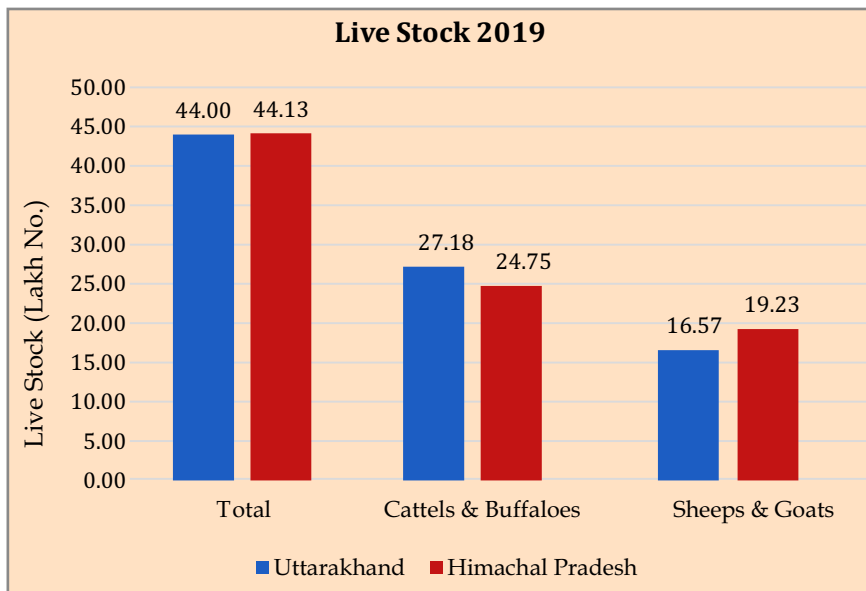

Pradesh provisional data of 21.18 Qtl./Ha. Productivity of oilseeds 9.60 Qtl./Ha for 2020-21 in Uttarakhand is slightly higher than Himachal Pradesh provisional data of 7.19 Qtl./Ha. Food sufficiency indicator shows that per capita production of cereals in Himachal Pradesh for the year 2020-21 is 190.46 kg, which is higher than Uttarakhand's figure of 167.36 kg. This is owing to less population of Himachal Pradesh.

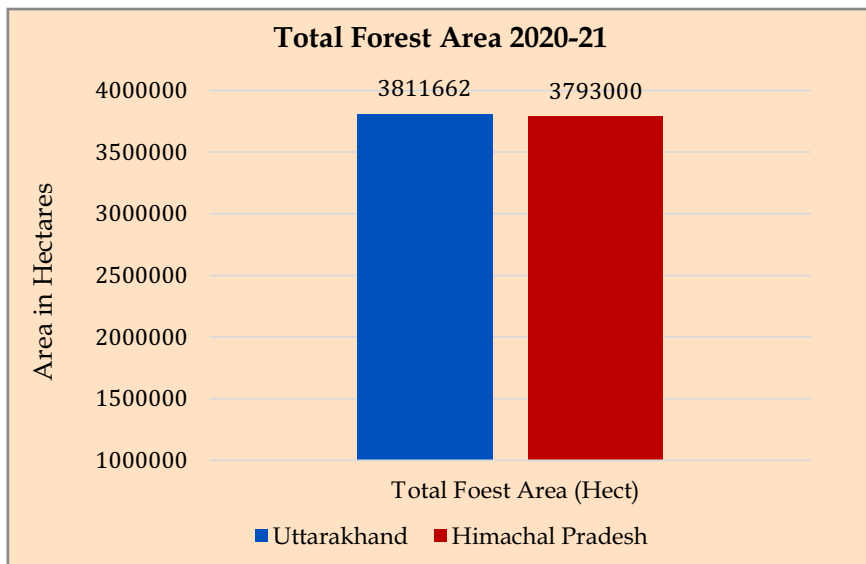
2.2 Horticulture: Uttarakhand leads in the production of fruits. In the year 2020-21 production of fruits in Himachal Pradesh was 624490 MT while it was 648896 MT in Uttarakhand. The area under fruits cultivation in Himachal Pradesh was 234779 Hectare, which is higher than 181070 Hectare in Uttarakhand. This reflects that the productivity of fruits in Uttarakhand is higher than in Himachal Pradesh.

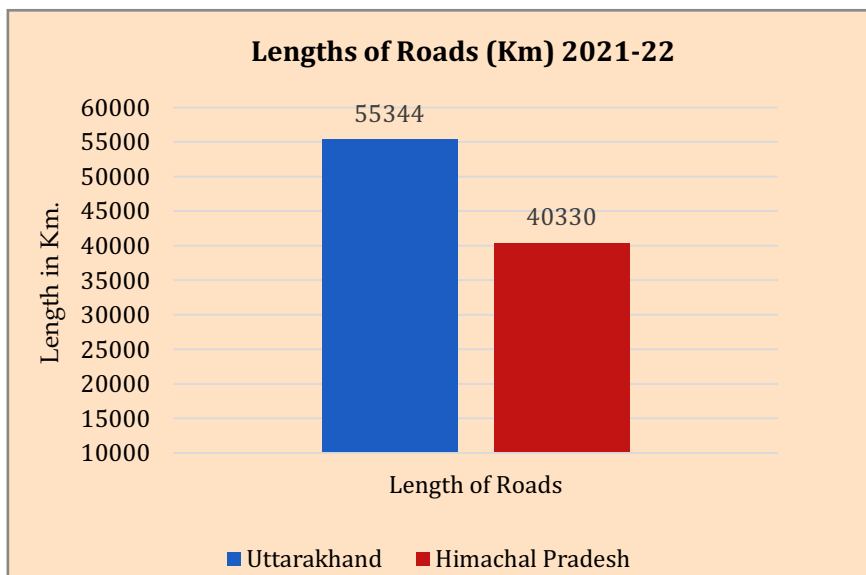

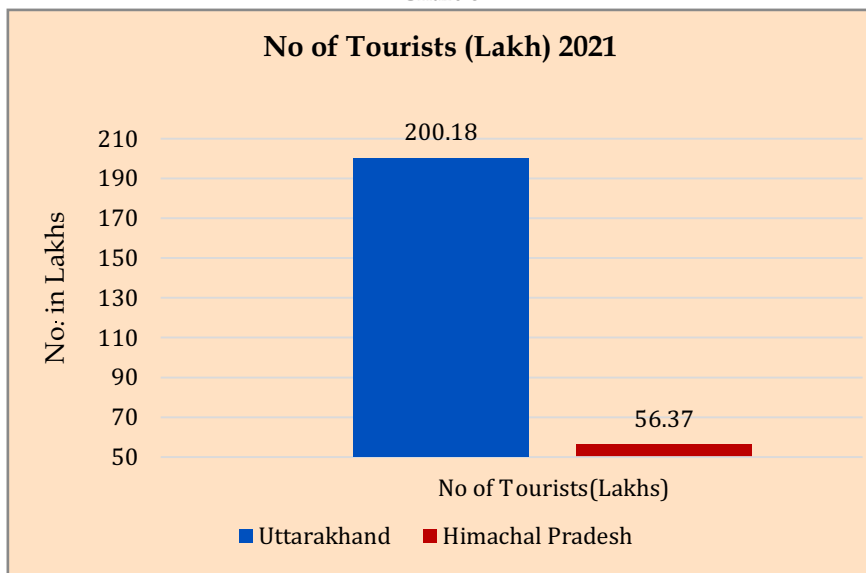

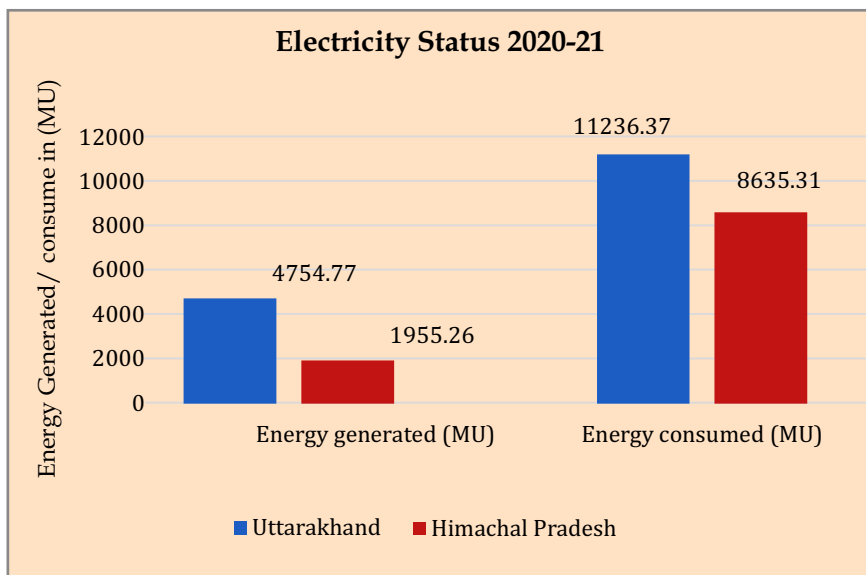
III: INFRASTRUCTURE DEVELOPMENT

3.1 Roads length: Total Length of Motorable Roads including Light Vehicle Roads in Himachal Pradesh is 40,330 Kms which is less in number than Uttarakhand. Total Length of Motorable Roads in Uttarakhand is 55,344 Kms. Though the total length of roads in Uttarakhand is higher than Himachal Pradesh but length of roads per lakh Population in Himachal Pradesh is higher than Uttarakhand, because Uttarakhand is more populated than Himachal Pradesh. Length of roads per lakh population in Himachal Pradesh is 521.06 Kms for the year 2021-22, while length of roads per lakh population in Uttarakhand is 477.64 Kms for the same year.

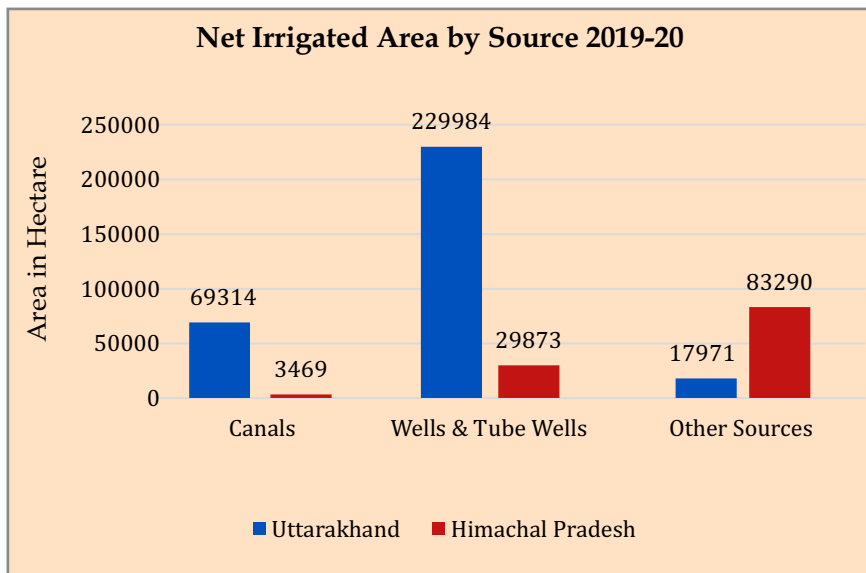
3.2 Tourism: Himachal Pradesh and Uttarakhand are stunning destinations in India having so many similarities. Himachal Pradesh is known for its colorful mountain, landscapes and adventurous activities while Uttarakhand offers a peaceful religious atmosphere in the middle of nature with rich cultural heritage. Though the total number of tourist reaching Uttarakhand is much more than that of Himachal Pradesh, As percentage of total tourist way ahead in attracting foreign and high spending tourists due to availability of better infrastructural facilities. Uttarakhand dominates in pilgrimage and religious tourism. Tourists' arrival in Himachal Pradesh was 56.37 lakh (56.32 Lakh Indian and 0.05 Lakh Foreigners) in the year 2021 which is comparatively less than Uttarakhand. Total number of tourists in Uttarakhand for the year 2021 was 200.18 lakh (200.03 lakh Indians and 0.15 lakh Foreigners).

3.3 Electricity: Uttarakhand leads in power sector. The Total Installed Capacity of power in Uttarakhand is 1322.56 MW which is nearly 2.70 times to Himachal Pradesh (487.45 MW) in the year 2020-21. As far as electricity generation is concerned in year 2020-21 generation of energy in Uttarakhand (4754.77 MU) is 2.43 time more than Himachal Pradesh (1955.26 MU).

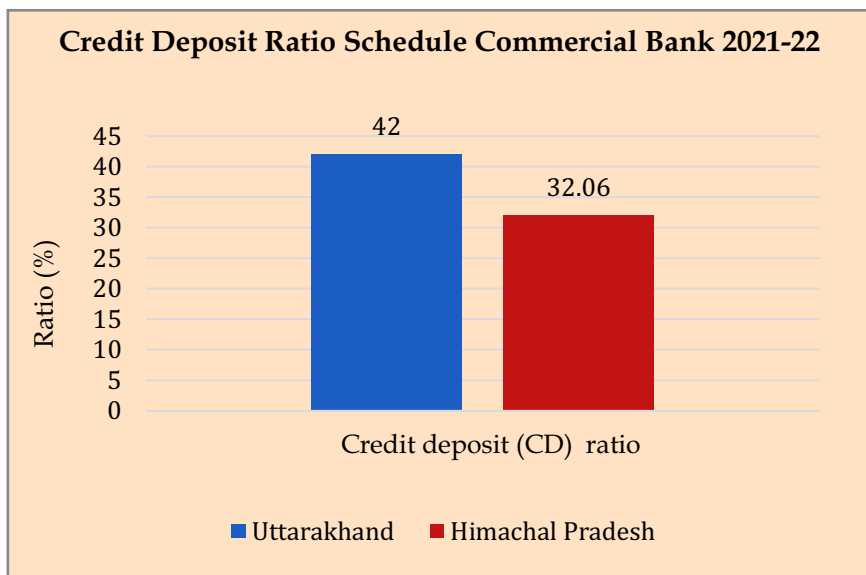

3.4 Irrigation: On the basis of consolidated figures of Uttarakhand for the year 2019-20 it appears that Uttarakhand out performs Himachal Pradesh with respect to the irrigational facility. As far as Net Irrigated Area by source is concerned, Uttarakhand leads in irrigation by canal. For Uttarakhand irrigated area by canal is 69314 hectare whereas for Himachal Pradesh it is 3469 hectares only. It shows that command area of irrigation of Uttarakhand through canal is higher than Himachal Pradesh. Main source of irrigation in Himachal Pradesh are other sources.

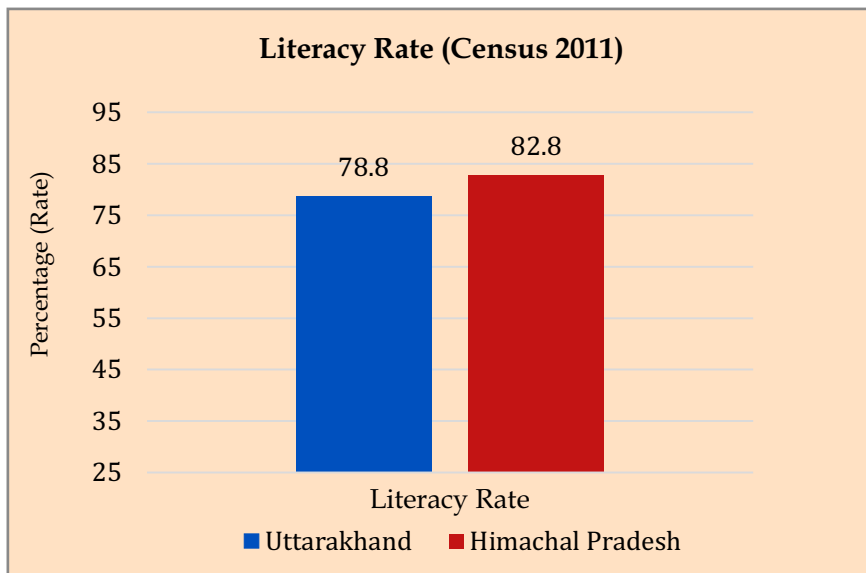

3.5 Banking: During the year 2021-22 Credit Deposit Ratio of Commercial Banks for Uttarakhand (42) and Himachal Pradesh (32.06) are lower than natural figure. There fore it is clear that both the States need to make more efforts for ensuring better investments in various economic sectors.

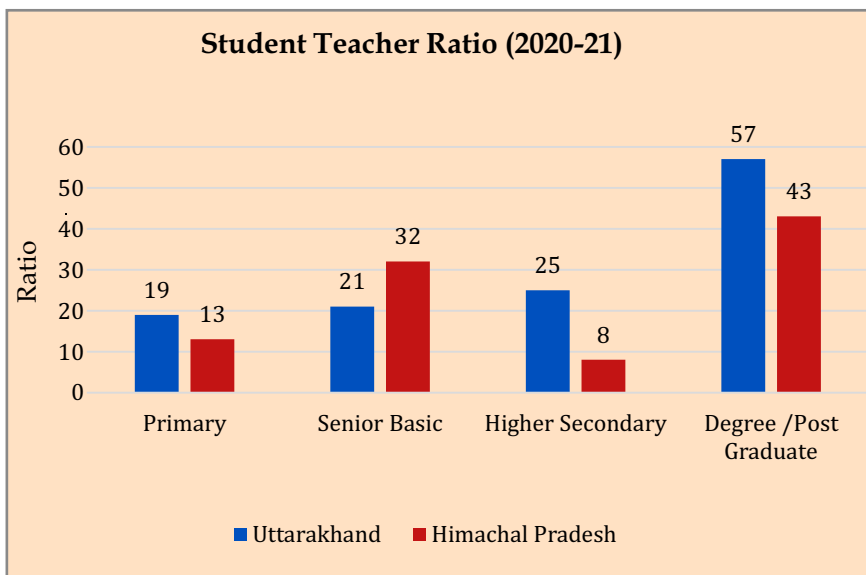

IV: SOCIAL SECTOR - EDUCATION AND HEALTH

4.1 Literacy and Education: As per Census 2011 Uttarakhand has Literacy Rate of 78.8 which is slightly below the corresponding figure (82.8) of Himachal Pradesh. The number of Junior Basic Schools per lakh population in Himachal Pradesh (137.77) is higher as compared with the figure of 117.04 in case of Uttarakhand for the year 2020-21. In the same year the number of Senior Basic Schools per lakh population in Uttarakhand (46.11) is more as compared the corresponding figure in Himachal Pradesh (25.38) for the year 2020-21. The number of higher secondary school per lakh population in Uttarakhand (33.14) is slightly lower as compared with the figure of (36.49) in case of Himachal Pradesh for the year 2020-21.

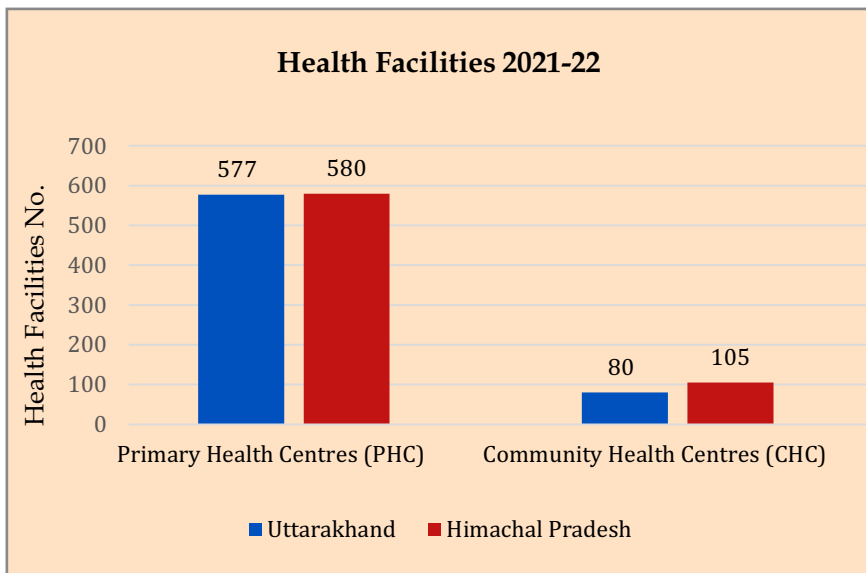

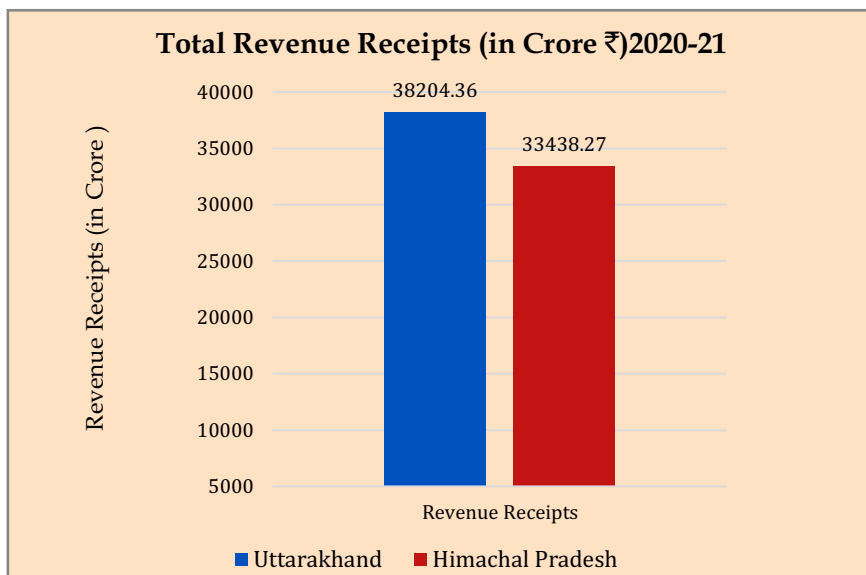
4.2 Health: In the year 2021-22, number of beds in Govt. hospitals per lakh population for Uttarakhand is 72 while the corresponding figure for the Himachal Pradesh is 190. There is a large difference between the No. of Primary Health Center and Community Health Center. Number of PHC's in Uttarakhand for the year 2021-22 was 577 while it was 58 in Himachal Pradesh. CHC for Uttarakhand is 8 in number while that of Himachal Pradesh is 94. Though Birth Rate, Death Rate and Infant Mortality Rate are the important indicators to judge the extent of health facility. other indicators also play vital role. Birth Rate per thousand of population for the year 2020 in Himachal Pradesh is 15.3 whereas the corresponding figure for Uttarakhand is that of 16.6. Death Rate per thousand of population of Himachal Pradesh (6.8) is slightly greater than the Uttarakhand (6.3). Infant Mortality Rate per thousand of population of Uttarakhand (24) is relatively much greater than Himachal Pradesh (17).

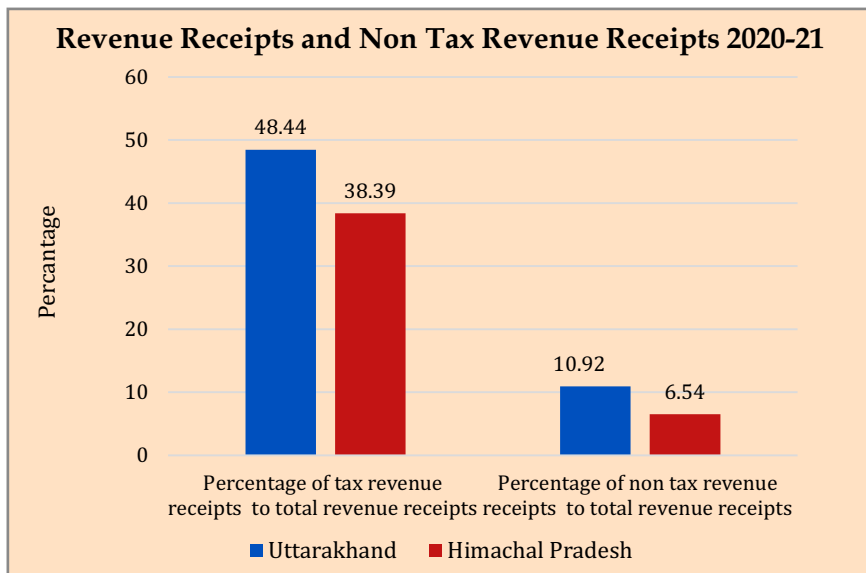
5.1 Revenue Receipts & Expenditure: While analyzing the State Finance, It is important to compare the revenue receipts between both states. Percentage of tax revenue to total revenue for Uttarakhand for the period 2020-21 is 48.44 while the corresponding figure of Himachal Pradesh is that of 38.39. Percentage of non-tax revenue to total revenue

for Uttarakhand (10.92) is much higher than the Himachal Pradesh (6.54) for the period 2020-21. Per capita revenue receipts of Uttarakhand for the year 2020-21 was ₹ 33314, whereas in case of Himachal Pradesh the corresponding figure was ₹ 45224. In case of per capita revenue expenditure for the same period, Himachal Pradesh (₹ 45354) is higher in number than Uttarakhand (₹ 32343).

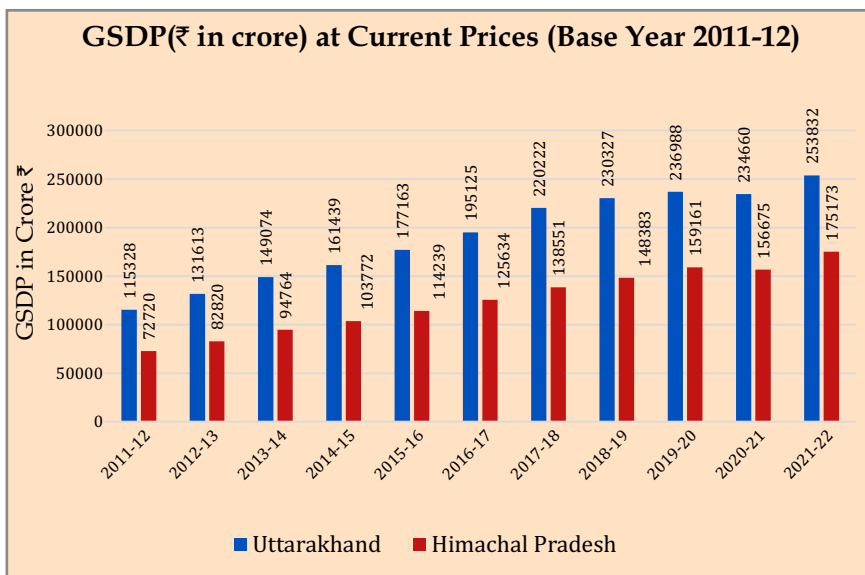

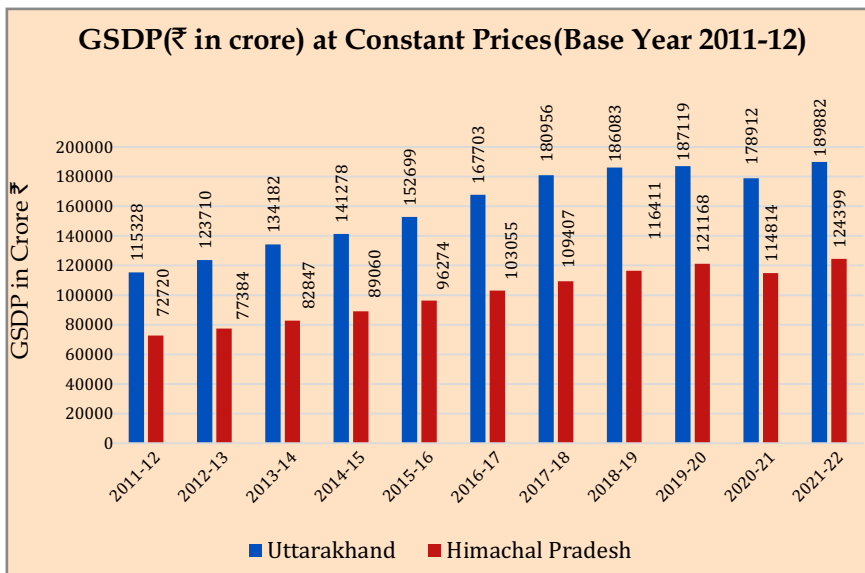

From the above table it is very clear that Growth Rate of GSDP at current price of Uttarakhand has increased to 8.17 in (2021-22) from, -0.98 in (2020-21). In Himachal Pradesh Growth Rate of GSDP at current price increased from 11.81 in (2021-22) to -1.56 in (2020-21).

GSDP of Uttarakhand at Constant Prices increased from ₹ 115328 Crore in the year 2011-12 to ₹ 189882 Crore in the year 2021-22. Same figures for Himachal Pradesh during the period were ₹ 72720 Crore and ₹ 124399 Crore respectively.

Uttarakhand, Himanchal Pradesh and India Important Indicators

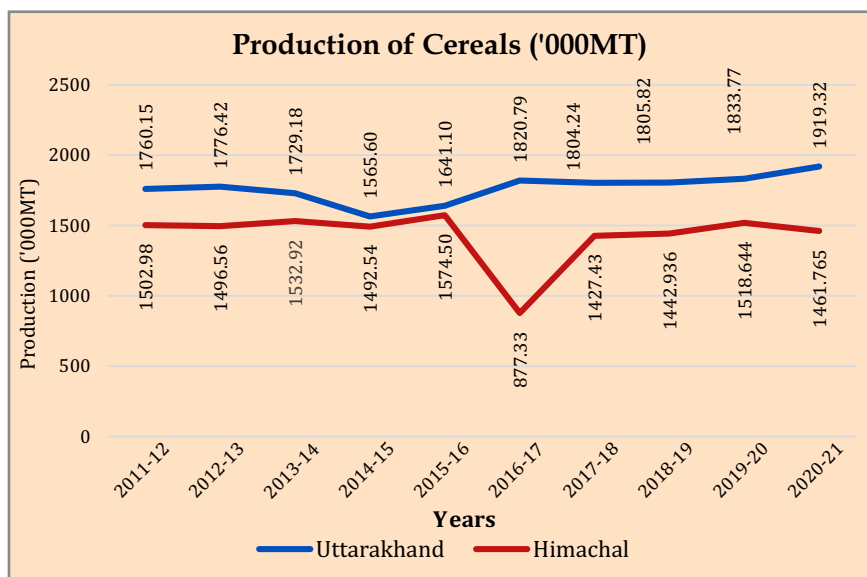

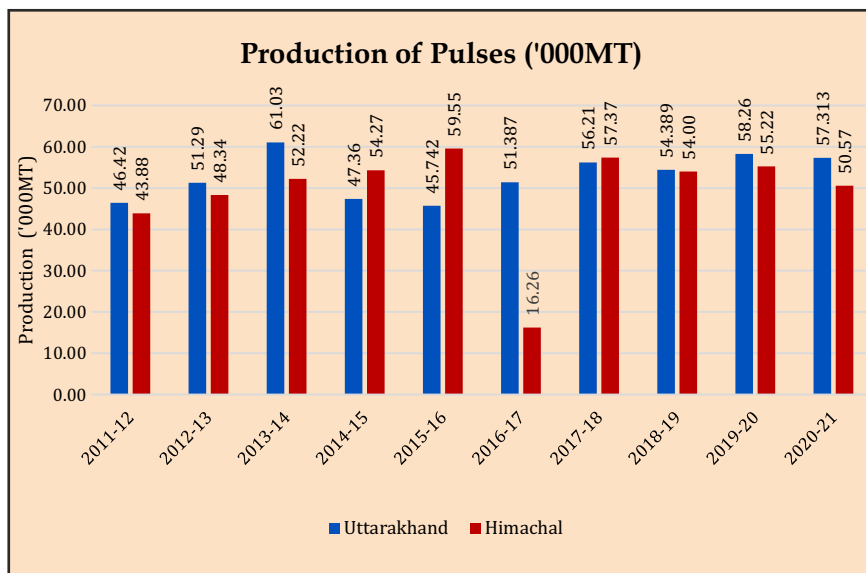

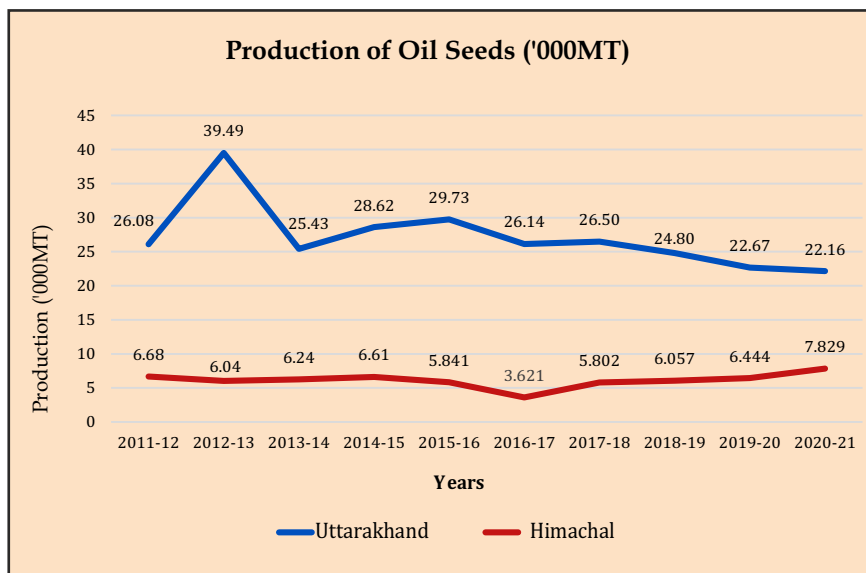

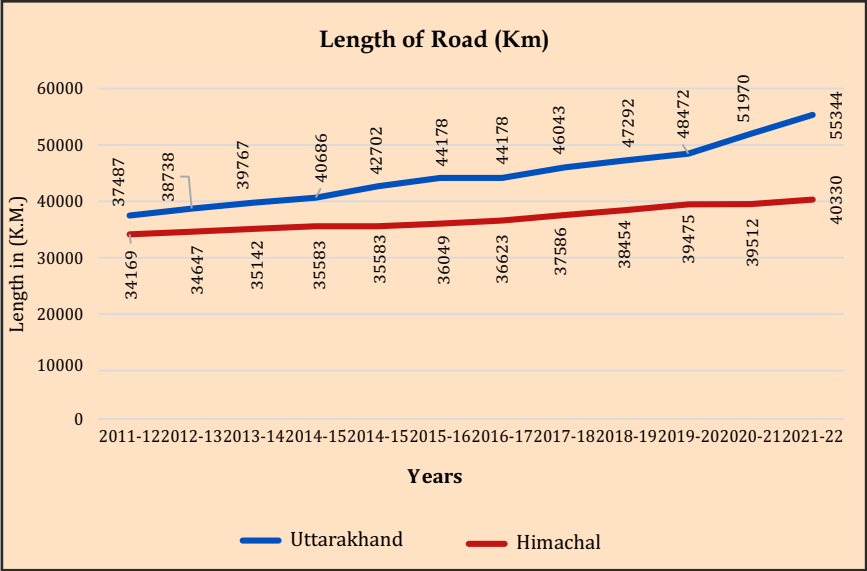

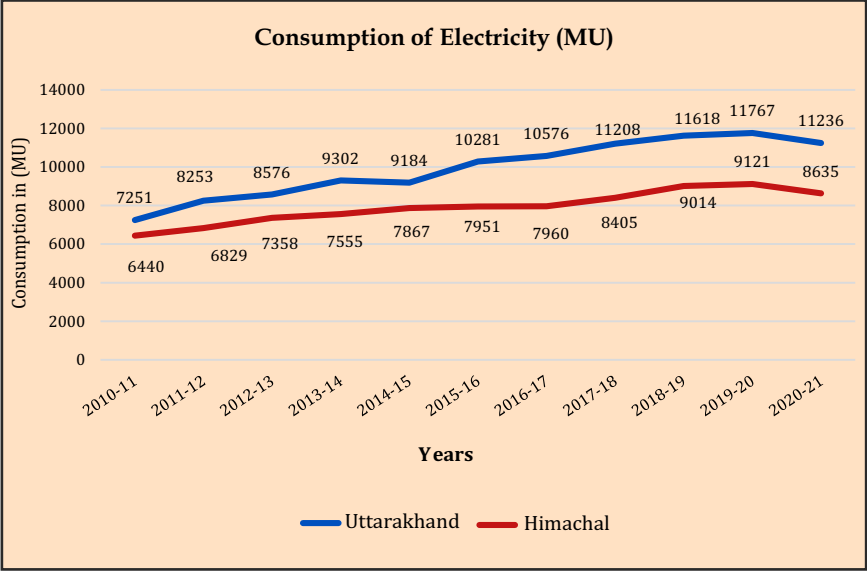

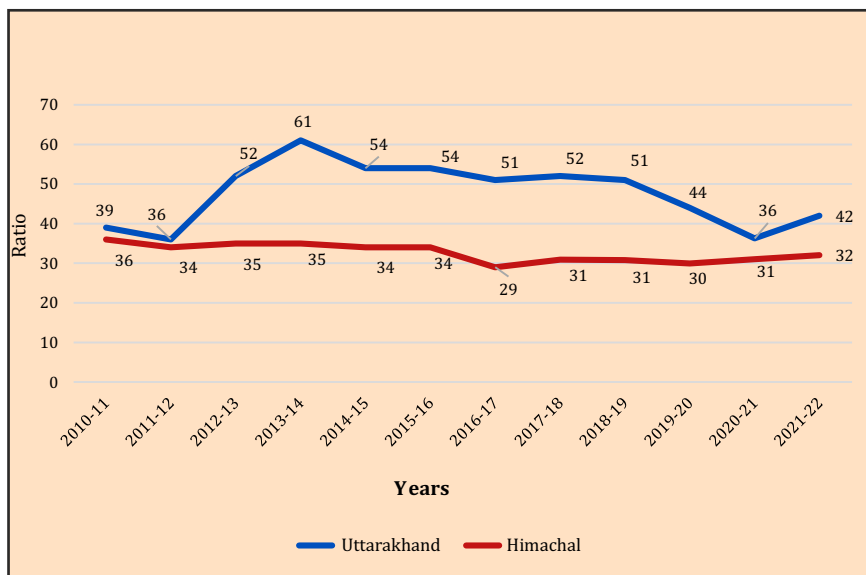

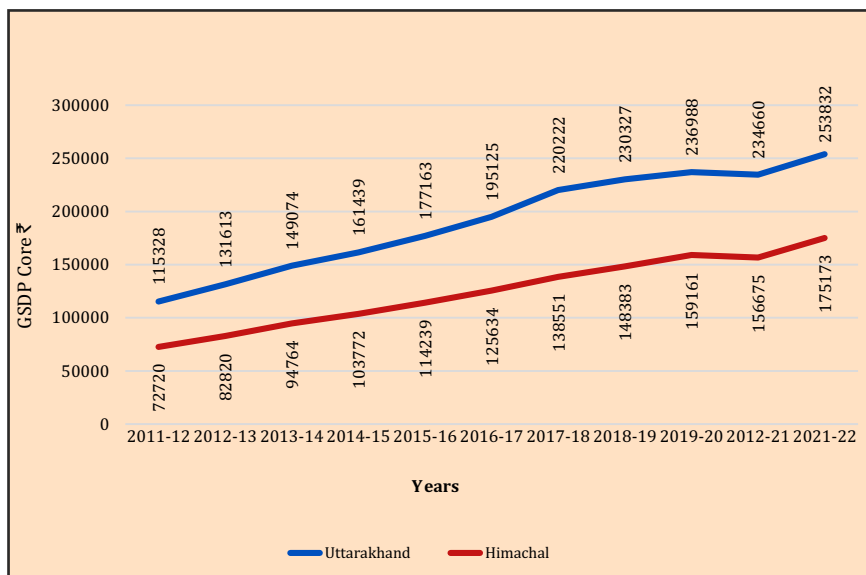

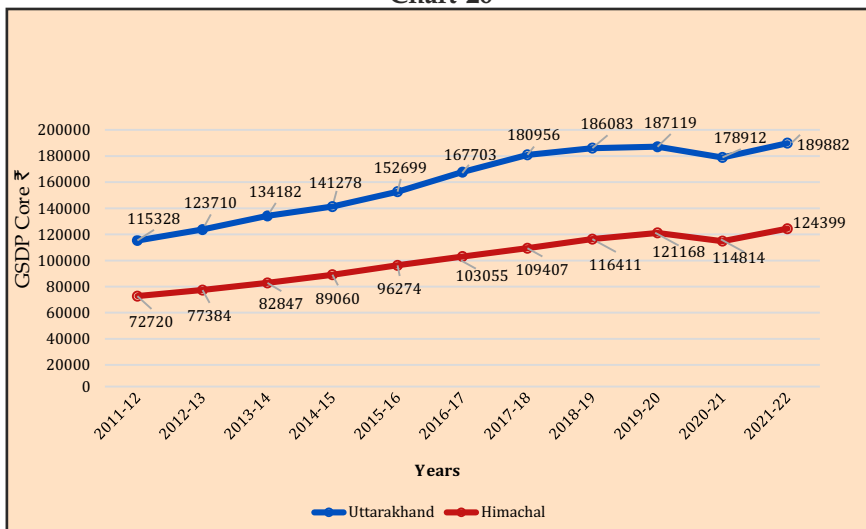

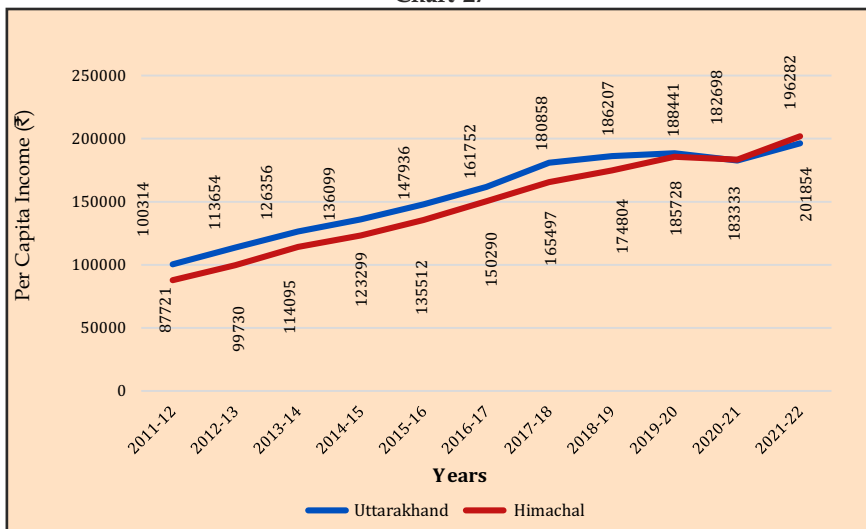
