- vii. In case of Group 'A' post, the contract can be renewed up to total 3 years based on the performance appraisal which is to be initiated by Director of respective National Institute and to be reviewed by Joint Secretary and Chairperson, Executive Council of Concerned Institute.
- viii. The contractual appointment would be on full time basis and they would not be permitted to take up any other commercial assignment during the period of consultancy.
- ix. Any other assignments given to the staff to be carried out time to time
- x. The HRD staff shall be assigned duties aimed towards the objectives of Institute and DEPWD at large.
