4. All applicants should enclose last 5 years APAR. The applicants presently in service under 7<sup>th</sup> CPC pay scale should submit "Endorsement of the Present Employer" (in the prescribed format provided) in addition to the last 5 years APAR.
5. The serving Govt. employee appointed on deputation basis will be governed by the instructions issued by DoP&T.
6. Latest Experience -cum- Service Certificate issued by the present employer (with date of issue of the certificate after publication of this advertisement), clearly stating the name of the post presently held, date of initial appointment to the present post, pay level, nature of duties presently dealing with should be attached.
