2. Rates quoted should be inclusive of GST and all other applicable taxes, packing, forwarding, transportation and insurance charges, on F.O.R. (Free on Road) destination basis – CRC Kozhikode.
3. The firm should be an authorised dealer/distributor of the original manufacturer for the item(s) quoted, and shall enclose a valid authorization /dealership certificate along with the quotation.
4. Technical specifications/catalogue/brochure of the item(s) quoted shall be enclosed for evaluation. Test materials quoted must be the latest and currently valid edition/version, duly EC approved.
