Hon'ble Executive Chairman desired that teachers, NGOs and Panchayats, apart from Medical Officers posted at Primary Health Centres should be imparted training in the field of mental health. They should be sent to all schools, colleges and villages for counselling the needy.



#### LOK ADALATS AT THE DISTRICT AND TALUK LEVELS

The District and Sessions Judge, Special Division-II, Gangtok conducted 57 Lok Adalats during the quarter April to June, 2014 where 355 cases were taken up, out of which 176 cases were successfully settled.
