OUTREACH PROGRAMME UNDER NALSA (LEGAL SERVICES TO THE WORKERS IN THE UNORGANIZED SECTOR) SCHEME, 2015

Under the directions of Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim & Executive Chairperson, Sikkim SLISA and in pursuance to a letter of request of the public to have a programme about labour laws, as most of the public comprised of labourers working under the GREF and Army, a legal awareness and outreach programme under the NALSA (Legal Services to the Workers in the Unorganized Sector) Scheme, 2015 was organized by Sikkim State Legal Services Authority in co-ordination with the Labour Department and Health & Family Welfare Department, Government of Sikkim on 22nd May, 2022 at the Community Hall, Kupup, Gangtok District which is located at an altitude of 13,000 feet above sea – level.

The participants comprised of Panchayats, Para-Legal Volunteers, labourers working both under organized and unorganized sectors, in and around Kupup and public of Kupup, Tanzey, Yakla, Gnathang, Tsomgo and Sherathang.
