MONTHLY NATIONAL LOK ADALAT:

As directed by NALSA, National Lok Adalat was observed on 8th August, 2015 at the District level. Cases related to bank matters were taken up. 195 cases were taken up wherein 101 cases were settled, 05 cases unsettled, 86 cases returned and 03 cases pending. Total amount awarded was ₹13,684,017/-.
