Memorandum of Understanding

Between

National Association for the Blind, India (NAB India)

And

Composite Regional Centre for Skill Development, Rehabilitation & Empowerment of Persons with Disabilities (CRC), Gorakhpur

This Memorandum of Understanding (MOU) is made and entered into on this [date] day of [month], [year], by and between the National Association for the Blind, India "NAB India" and Composite Regional Centre for Skill Development, Rehabilitation & Empowerment of Persons with Disabilities.

Purpose:

The purpose of this MOU is to establish a collaborative relationship between NAB India and CRC Gorakhpur to enhance services for persons with visual impairments in Eastern Uttar Pradesh.

Scope of Collaboration:

- 1. Providing Instructional Materials:
- NAB India will provide instructional materials in accessible formats such as braille or large print textbooks, tactile maps, enlarged diagrams, and threedimensional models.
- Support for ICT-Based Education:
- NAB India will offer hands-on training on ICT devices for children with visual impairments.
- 3. Collaboration in Digital Education:
- NAB India will provide teacher support to visually impaired students, helping them benefit from digital devices through the ADIP scheme.
- NAB India teachers will offer training on different software and apps.
- 4. Digital Library Collaboration:
- NAB India will launch a digital library called NAB Vani, which will be an area of collaboration with CRC Gorakhpur, particularly in respect to digital library resources.
- 5. ADIP Scheme Collaboration:
- NAB India will collaborate with CRC Gorakhpur within the catchment area, working with implementing partners and state/district branches.
- 6. Capacity-Building Activities:
- Both parties will collaborate on capacity-building activities, especially for children with visual impairments, through both offline and online modes.

Role of CRC, Gorakhpur

The parties agree that this Memorandum of Understanding (MoU) does not impose any financial obligations on CRC Gorakhpur. It is purely a non-financial MoU, NAB India is free to secure funding for all the above tasks from CSR funds or any other suitable donors in its network.

CRC Gorakhpur will provide all its schemes and services to the National Association for the Blind (NAB) to distribute them among deserving visually impaired and Divyang beneficiaries.

Additionally, CRC Gorakhpur will give full visibility to NAB India for all the services provided under this MoU, both within its premises and on other occasions.

Duration:

This MOU will commence on the date of signing and will continue for a period of one year unless terminated by either party with one months' written notice.

Review and Amendment:

This MOU may be reviewed annually and may be amended by mutual written consent of both parties.

Termination:

Either party may terminate this MOU with one months' written notice to the other party.
