

## **Memorandum of Understanding (MoU)**

This Memorandum of Understanding (MoU) is made on dated 27<sup>th</sup> June, 2024 between the Composite Regional Centre (CRC) Gorakhpur, Uttar Pradesh under the administrative control of NIEPVD, Dehradun, Ministry of Social Justice & Empowerment, Government of India (hereinafter referred to as "CRC Gorakhpur") and Udaan Empowerment Trust, having its registered office at Pathankot, Panjab. (hereinafter referred to as "Udaan").

### **1. Purpose**

The purpose of this MoU is to establish collaboration between Udaan Empowerment Trust and CRC Gorakhpur to empower and provide limitless opportunities to persons with disabilities (PwDs) through the initiatives of Radio Udaan and a braille magazine for Persons with Disabilities (PwDs).

### **2. Scope of Collaboration**

#### **a. Radio Udaan:**

- **Content Contribution:**

- CRC Gorakhpur will contribute the latest disability news, events, achievements, and best practices specifically from the state of Uttar Pradesh.
- CRC Gorakhpur will participate in interviews, discussions, and debates on trending topics and critical issues related to disabilities.
- CRC Gorakhpur will provide awareness programs on various schemes and benefits for PwDs by MSJ&E and the Government of Uttar Pradesh.
- CRC Gorakhpur will engage in disability advocacy and share information about the latest technologies for disability accessibility.
- CRC Gorakhpur will provide success stories and role models in the field of disability rehabilitation specifically from Uttar Pradesh.
- Udaan Empowerment Trust will provide slots in their community Radio programme

- **Future Program Development:**

- A future program on radio jockey skill training for nominated persons with visual impairment will be developed mutually.

#### **b. Braille Magazine for Visually Impaired Individuals:**

- **Subscription:**

- CRC Gorakhpur will subscribe to the braille magazine for visually impaired individuals for its library.

- **Content Contribution:**

- The braille magazine will provide space for CRC Gorakhpur to publish Uttar Pradesh-specific articles, events, and other relevant content.

#### **c. Training and Workshops:**

- **Skill Development:**

- Joint organization of training sessions and workshops for PwDs focusing on skill development on radio jockey.
- CRC Gorakhpur will provide venues and logistical support for these training sessions.

#### **d. Partnership Acknowledgment:**

- **Social Media Collaboration:**

- Udaan Empowerment Trust and CRC Gorakhpur will share and tag photographs and updates of events/sessions conducted in collaboration on their respective social media handles.

- **Quarterly Meetings:**

- Quarterly meetings will be conducted between CRC Gorakhpur and Udaan Empowerment Trust to review progress, share updates, and plan future events.

### **3. Period of Validity**

This MoU shall be valid for a period of one (1) year from the date of signing. It may be renewed upon mutual agreement of both parties. It is understood by both parties that this is a working, non-financial MoU.

### **4. Arbitration**

Any dispute arising from or in connection with this MoU shall be resolved through mutual consultations and agreements between the parties.
