Sir/Madam,

I am directed to inform that one post of Director of Prosecution in the Law Department, Government of Puducherry is proposed to be filled up on deputation basis for a period of one year initially. The post of Director of Prosecution belongs to General Central Service, Group 'A' (Gazetted) (Non-Ministerial) in level 11 in the pay matrix (Rs.67,700 – 2,08,700). Deputation to the said post is to be made from amongst the officers of the Central / State Government / Union Territories fulfilling the following eligibility criteria:-

- (a) (i) Holding analogous posts on regular basis in the parent Cadre / department; or  
(ii) with five years' service in the grade rendered after appointment thereto on a regular basis in the Level 10 in the Pay Matrix or equivalent in the parent cadre/ department; or  
(iii) with seven years' service in the grade rendered after appointment thereto on a regular basis in the Level – 7 in the Pay Matrix or equivalent in the parent cadre/ department and
- (b) Possessing the following educational qualifications and experience:-
- a. Degree in Law of a recognized University or equivalent;
  - b. Five years' experience as Public Prosecutor or equivalent experience in the Law/Legal Department of Central / State / Union Territory Administration.
  - c. Knowledge of Tamil.


(c) The maximum Age limit for appointment by deputation shall be not exceeding fifty six years as on the closing date of receipt of applications.



2. I am to request that wide publicity may be given to the above vacancy and applications in the prescribed form (Annexure-II) of suitable officers who satisfy the age, educational qualifications and experience and whose services can be spared immediately may be sent to this Department. The final selection of the candidate will be made in consultation with the Union Public Service Commission.
3. The applications of willing officers should reach the undersigned (in duplicate) along with their up-to-date CR Dossier, Vigilance Clearance Certificate and Integrity Certificate separately on or before 15-09-2021. While forwarding the application, a certificate showing that no minor/major penalty has been imposed on the officers in the past ten years may also be enclosed separately.
4. Applications received incomplete, otherwise than through proper channel and without the above mentioned documents and after the due date will not be entertained. Further, the candidate who applies for the post will not be allowed to withdraw his candidature subsequently.
