In exercise of the power conferred by the proviso to Article 309 of the Constitution of India, the Governor of Haryana, in consultation with Haryana Public Service Commission, is pleased to declare the posts of Deputy District Attorney (Group - B) Governed under the Haryana State Prosecution Legal (Group- B) Service Rules, 2001 as (Group -A) posts and the said Rules shall be read as Haryana State Prosecution Legal (Group- A) Service Rules, 2001 in respect of the posts of Deputy District Attorney. All the other terms & conditions mentioned in said Rules shall remain unchanged.


