

**HARYANA GOVERNMENT

ORDER

The Governor of Haryana is pleased to promote Smt. Savita Chaudhary and Sh. Anil Kumar Bhardwaj, Deputy District Attorney's of Prosecution Department, Haryana to the post of District Attorney in the pay scale of FPL-12, 78800-197200, from the date they take over as such, subject to the condition that no adverse entries are found later in the ACRs of Smt. Savita Chaudhary for the year 2013-14(01.04.2013 to 25.08.2015) & 2014-15 for which integrity certificate received and Sh. Anil Kumar Bhardwaj for the year 2014-15(25.11.2014 to 31.03.2015) for which integrity certificate received. They shall have no right of seniority over and above Smt. Poonam Verma and Smt. Renu Bala Jain, who are seniors to them, if found eligible as per Rules on receipt of the awaited ACRs for the year 2013-14, 2014-15(01.04.2014 to 27.08.2014), 2015-16(01.04.2015 to 16.08.2015), 2016-17 (01.04.2016 to 08.09.2016) & 2017-18 (01.04.2017 to 30.06.2017) in respect of Smt. Poonam Verma and on receipt of the awaited ACRs for the year 2015-16, 2016-17 and 2018-19 in respect of Smt. Renu Bala Jain.

2. These promotions are subject to condition that if any Handicapped Assistant District Attorneys/Deputy District Attorneys is to be promoted in the reservation of Handicapped Quota as provided by the Government then the junior most will be reverted.

3. The cases of promotion of the following Deputy District Attorneys have been considered and they have not been found eligible for promotion to the posts of District Attorneys for the reasons given in the columns against their names:-
