Filling up of 2(two) post of Deputy District Attorney in the Law & Prosecution Department, Union Territory, Chandigarh Administration on deputation basis.

Reference on the subject cited above.

It is intimated that the Legal Remembrancer-cum-Director of Prosecution, Chandigarh Administration, Chandigarh, vide his letter No. (3/2018/15)-2019/19178 dated 19.11.2019 has requested to send the panel of suitable officers for filling up the 02 posts of Deputy District Attorney in Chandigarh Administration. A copy of above said letter dated 19.11.2019 can be downloaded from the website of this department i.e. prosecutionharyana.gov.in. The Law & Prosecution Department, Union Territory, Chandigarh Administration has intended to fill up these two post of Deputy District Attorney on deputation basis on following terms & conditions:-

1. No official/officer shall be taken on deputation unless he possesses atleast five year regular service as such in his/her parent cadre. It is, however, clarified that regular service shall not include service on adhoc basis but includes probation period.
2. No official/officer shall be taken on deputation who has already attained the age of 55 years.
3. The official/officer shall initially be taken on deputation for a period of one year which shall be extended upto three years or till the direct recruitment to the post is made whichever is earlier.

It is therefore, requested that eligible Deputy District Attorneys who fulfil the eligibility criteria prescribed by the Chandigarh Administration and willing of posting in Chandigarh Administration, Chandigarh, may sent their willingness within 10 days from the issuance of this letter in this department.

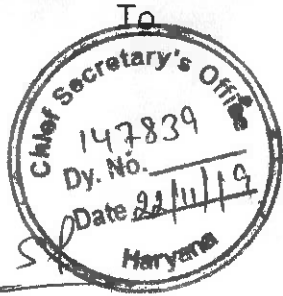
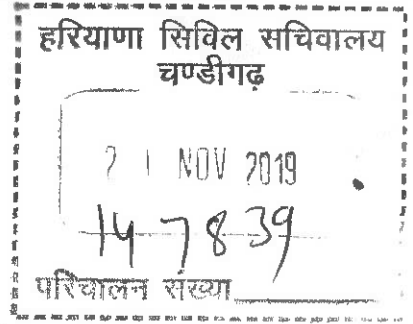

Subject:- **Filling up of 2 (two) post of Deputy District Attorneys in the Law & Prosecution Department, Union Territory, Chandigarh Administration**

Sir/Madam

I am directed to refer on the subject cited above and to inform you that this department intends to fill up two posts of Deputy District Attorneys in the pay scale of Rs.15600-39100+5400 Grade Pay on deputation basis from amongst the officers holding analogous post on regular basis and carrying the same or identical scale on the following terms and conditions:-

1. No official/officer shall be taken on deputation unless he possesses atleast five year regular service as such in his/her parent cadre. It is, however, clarified that regular service shall not include service on adhoc basis but includes probation period.
2. No official/officer shall be taken on deputation who has already attained the age of 55 years.
3. The official /officer shall initially be taken on deputation for a period of one year which shall be extended upto three years or till the direct recruitment to the post is made whichever is earlier.

It is, therefore, again requested to send the panel comprising the names of atleast three suitable officers for each post alongwith their ACR/APAR dossiers for the last five years and the certificate to the effect that no departmental/vigilance enquiry is contemplated or pending against the said officers.
